Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Century Park South bounded on the north by SW 136 Street, on the east approximately 1,850 feet west of SW 152 Avenue, on the south by the C.S.X. Right of Way, and on the west by the C-1W Canal.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 11, which is represented by Commissioner Joe A. Martinez.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this plat as all improvements are in place.

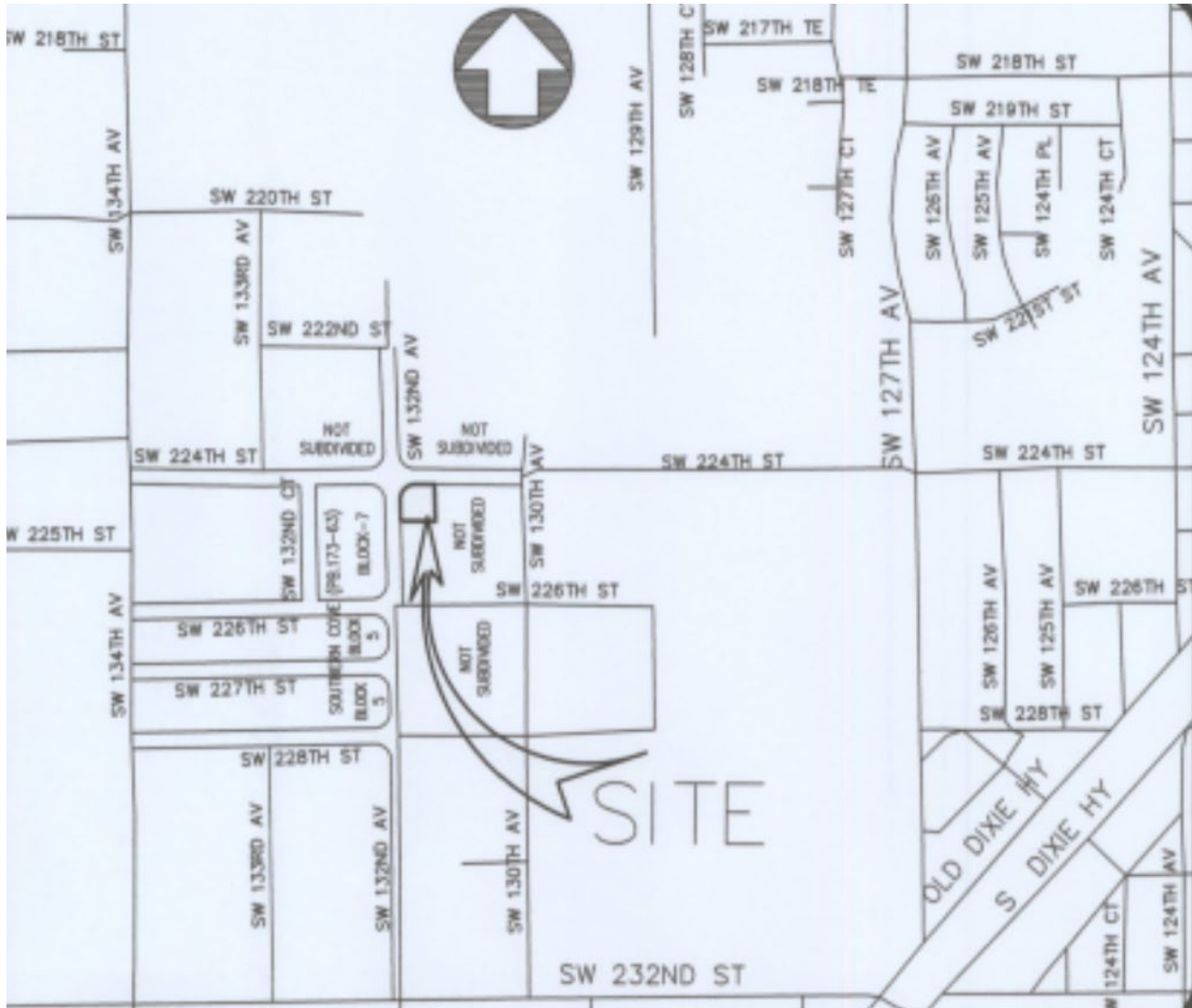

RESOLUTION NO. R-622-20

RESOLUTION APPROVING THE PLAT OF CENTURY PARK SOUTH FILED BY CENTURY HOMEBUILDERS GROUP, LLC LOCATED IN THE NORTHWEST 1/4 OF SECTION 21, TOWNSHIP 55 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY SW 136 STREET, ON THE EAST APPROXIMATELY 1,850 FEET WEST OF SW 152 AVENUE, ON THE SOUTH BY THE C.S.X. RIGHT OF WAY, AND ON THE WEST BY THE C-1W CANAL)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Century Homebuilders Group, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as “Century Park South,” the same being a replat of a portion of Tract “A” of “Tamiami-157th Avenue,” according to the plat thereof, as recorded in Plat Book 162, at Page 2 of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 21, Township 55 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any

zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.

The foregoing resolution was offered by Commissioner **José "Pepe" Diaz**, who moved its adoption. The motion was seconded by Commissioner **Sally A. Heyman** and upon being put to a vote, the vote was as follows:

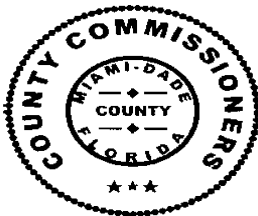
