Subject: Resolution Authorizing the Approval of the Application of Ride Care, LLC for Three
Certificates of Public Convenience and Necessity

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the application of Ride Care, LLC for three Certificates of Public Convenience and Necessity to operate three non-emergency vehicles.

Scope

These Certificates of Public Convenience and Necessity are countywide, allowing the certificate holder to operate in the unincorporated and incorporated areas of Miami-Dade County.

Fiscal Impact

Licensing, operating, permit and inspection fees are collected by the Department of Transportation and Public Works (DTPW) to support regulatory activities. There is an annual regulatory fee of \$625 per certificate that will yield \$1,875 in revenue annually for the new certificates. The County also collects \$38 per vehicle inspection; with inspection frequency varying with the vehicle age from one to four per year.

Track Record/Monitor

This applicant will be a new certificate holder upon approval and complies with all requirements of the Code of Miami-Dade County. DTPW, through its Passenger Transportation Regulatory Division, will be responsible for monitoring this company.

Background

On December 18, 1980, the Board adopted Ordinance 80-145, later codified in Chapter 4, Article III of the Code of Miami-Dade County (Code), providing for the regulation of non-emergency medical transportation. Section 4-44 of the Code provides the procedures to be followed by the County in processing certificate applications. Based upon those requirements, the Board may issue or refuse to issue the certificate as applied for, may issue the certificate with modifications or upon such terms and conditions as in its judgment the public interest may require. In reaching a determination, the Board shall consider the application, the Mayor's recommendation, all matters presented during the public hearing, and among others, the following criteria:

- (1) The ability of the applicant to provide the proposed service;
- (2) The adequacy of the management plan of the applicant; and
- (3) The benefits that will accrue to the public interest from the proposed service.

Ride Care, LLC, located at 2332 Galiano Street, Coral Gables, Florida 33134, seeks to obtain one Certificate of Public Convenience and Necessity to provide wheelchair non-emergency medical transportation service, one Certificate of Convenience and Necessity to provide combination wheelchair/stretchers non-emergency medical transportation service and one Certificate of Public Convenience and Necessity to provide sedan non-emergency medical transportation service to individuals requiring these types of transportation.

The applicant seeks to transport patients to and from various medical facilities throughout the County Monday through Saturday, from 5 a.m. to 7 p.m. Non-emergency transportation rates are not regulated by the County. However, under the Code, the Certificate Holder must file their rates with DTPW and post them within the passenger compartment section of each vehicle. The proposed rate schedule is attached. The vehicles operated under these certificates will have to meet the requirements of Section 4-49 of the County Code, establishing vehicle inspection frequencies.

The management plan submitted by Mr. Foiaid Mohamed, Manager of Ride Care, LLC, includes maintenance, communication and recordkeeping systems which meet the requirements of the County Code. All required financial statements and credit references have been submitted. The proposed service standards meet all requirements of the County Code, and adequately meet transportation and comfort needs. A background investigation revealed that all officers of the corporation meet the criteria of the County Code.

The proposed service to be provided under these certificates will increase the availability of licensed non-emergency medical transportation in the County, thus increasing competition and high service standards to the public.

TRANSPORTATION SERVICES

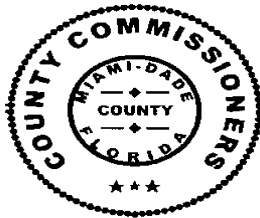
WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,
