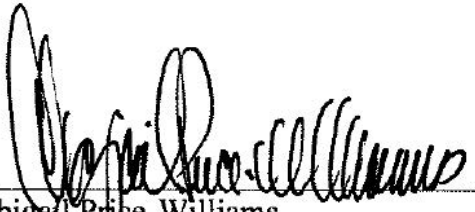

RESOLUTION NO. _____ R-1044-20

RESOLUTION ALLOCATING \$500,000.00 FROM THE COMMUNITY DISPARITIES SUBCOMMITTEE RESERVE IN THE FISCAL YEAR 2019-2020 COUNTY BUDGET TO FUND FUTURE BOUND MIAMI, CHILDREN'S SAVINGS ACCOUNTS; DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO TAKE ALL ACTIONS NECESSARY TO EFFECTUATE THE FOREGOING, INCLUDING EXECUTING GRANT AGREEMENTS; REQUIRING A REPORT

>>WHEREAS, at the June 9, 2020, Community Disparities Subcommittee ("CDS") meeting, members heard a presentation about Future Bound Miami, a children's savings account program designed to increase postsecondary attainment; and

WHEREAS, Future Bound Miami is the first universal children's savings account program in the State of Florida, but there are over 500,000 children in 34 states participating in similar children's savings account programs; and

WHEREAS, as part of the program, upon entering kindergarten, each child automatically gains access to a no-fee savings account in their name at the South Florida Educational Federal Credit Union; and

WHEREAS, the account is opened with an initial seed deposit of \$25 or \$50 for children who qualify for free and reduced lunch; and

WHEREAS, over time, the children's savings account grows through family contributions and earned incentives and helps children and their families build savings for the future; and

WHEREAS, the savings account is accessible only to the child upon high school graduation and to help pay for postsecondary education; and

WHEREAS, children's savings accounts have been studied for nearly 30 years; and

WHEREAS, key findings of peer-reviewed research points to the ability of the children's savings accounts to expand educational and economic opportunities; and

WHEREAS, in particular, research from Washington University in St. Louis, Center for Social Development, shows that children with college savings of as little as \$1 to \$499 are three times more likely to attend college and four times more likely to graduate; and

WHEREAS, other research shows that children's savings accounts improve early childhood development and academic performance, increase a child's future financial capability, and reduce the racial wealth gap; and

WHEREAS, this program is being implemented by a regional consortium; and

WHEREAS, this formal advisory board is responsible for overseeing and approving the decisions guiding the children's savings accounts program and its membership includes Catalyst Miami, Inc., The Children's Trust, the United Way of Miami-Dade County, the Miami-Dade County Public Schools (M-DCPS), the Miami Foundation, the Health Foundation of South Florida, the South Florida Educational Federal Credit Union, Junior Achievement of Greater Miami, and Sant La Haitian Neighborhood Center; and

WHEREAS, during the 2019-2020 school year, Future Bound Miami launched for 2,300 kindergarten students in 30 M-DCPS elementary schools within the City of Miami; and

WHEREAS, Future Bound Miami has a goal of expanding to a countywide M-DCPS program by the 2023-2024 school year, reaching approximately 23,000 kindergarten students once the program is at scale; and

WHEREAS, the annual seed investment per kindergarten student is up to \$50 and, once at scale, the annual investment for each kindergarten cohort is less than \$1 million; and

WHEREAS, Citi, Bank of America and the Jorge M. Perez Family Foundation have already invested in the program, and further investments for deposits and incentives will come from the public and private sectors; and<<¹

WHEREAS, the fiscal year 2019-2020 budget adopted by this Board set aside \$1,000,000.00 in a reserve for the ~~[[Community Disparities Subcommittee (“]]CDS[[”]]~~ (“CDS Reserve”) for programs for which seed funding or initial funding for a pilot effort may be appropriate in order to determine viability, or to develop strategies to address equality gaps resulting in disparities within our communities; and

WHEREAS, pursuant to Ordinance No. 19-85, >>which approved and adopted the countywide general fund budget,<< recommendations made by the CDS are forwarded to the full Board for approval; and

WHEREAS, on June 9, 2020, following a presentation by Catalyst Miami, Inc., the CDS approved a motion to allocate \$500,000.00 from the CDS Reserve to Future Bound Miami, as matching funds for the children’s savings accounts program[[,]] >>; and

WHEREAS, this allocation of funds can help expand the program into 98 additional elementary schools in Miami-Dade County,<<

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Accepts the recommendation of the CDS and approves the allocation in the amount of \$500,000.00 from the CDS Reserve in the fiscal year 2019-2020 County budget to fund >>the expansion of the<< Future Bound Miami, children’s savings accounts >>program<<.

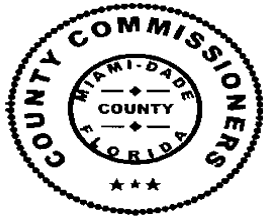
Section 2. Authorizes the County Mayor or County Mayor’s designee to take all actions necessary to effect the purposes of this resolution, including executing any agreements or documents, subject to approval for form and legal sufficiency by the County Attorney’s Office, and exercising termination and modification provisions of any such agreements, subject to approval for form and legal sufficiency by the County Attorney’s Office.

>>**Section 3.** Directs the County Mayor or County Mayor’s designee to provide a written report within 6 months of the effective date of this resolution detailing the status of the grant and expansion of the Future Bound Miami children’s savings accounts program. The completed report shall be placed on an agenda of the Board pursuant to Ordinance No. 14-65.<<

The Prime Sponsor of the foregoing resolution is the Community Disparities Subcommittee. It was offered by Commissioner **Eileen Higgins** , who moved its adoption. The motion was seconded by Commissioner **Daniella Levine Cava** and upon being put to a vote, the vote was as follows:
