SUBJECT: Resolution amending Resolution No. R-332-20 relating to financial relief plans at the airports due to the effects of coronavirus disease 2019 (COVID-19); extending the term of relief for certain business partners at Miami International Airport on a month-to-month basis from January 1, 2021 to no later than April 30, 2021 for a total amount of \$32,996,656.00, subject to termination upon a finding of a change in circumstances; authorizing the County Mayor to execute amendments to agreements with certain airport business partners and to execute any subsequent agreements necessary to effectuate the extension of the Financial Relief Plan and exercise all provisions contained therein, including termination, provided that any relief extended shall be subject to approval by the Federal Aviation Administration and compliance with the Airport Amended and Restated Trust Agreement and Bond Covenants; directing the County Mayor to strategize and develop a forward-looking long-term plan to provide financial assistance to concessionaires at Miami International Airport due to the effects of COVID-19; and directing the County Mayor to provide reports pursuant to Ordinance No. 14-65

RESOLUTION NO. R-1254-20

RESOLUTION AMENDING RESOLUTION NO. R-332-20 RELATING TO FINANCIAL RELIEF PLANS AT THE AIRPORTS DUE TO THE EFFECTS OF CORONAVIRUS DISEASE 2019 (COVID-19); EXTENDING THE TERM OF RELIEF FOR CERTAIN BUSINESS PARTNERS AT MIAMI INTERNATIONAL AIRPORT ON A MONTH-TO-MONTH BASIS FROM JANUARY 1, 2021 TO NO LATER THAN APRIL 30, 2021 FOR A TOTAL AMOUNT OF \$32,996,656.00, SUBJECT TO TERMINATION UPON A FINDING OF A CHANGE IN CIRCUMSTANCES; AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO EXECUTE AMENDMENTS TO AGREEMENTS WITH CERTAIN AIRPORT BUSINESS PARTNERS AND TO EXECUTE ANY SUBSEQUENT AGREEMENTS NECESSARY TO EFFECTUATE THE EXTENSION OF THE FINANCIAL RELIEF PLAN AND EXERCISE ALL PROVISIONS CONTAINED THEREIN, INCLUDING TERMINATION, PROVIDED THAT ANY RELIEF EXTENDED SHALL BE SUBJECT TO APPROVAL BY THE FEDERAL AVIATION ADMINISTRATION AND COMPLIANCE WITH THE AIRPORT AMENDED AND RESTATED TRUST AGREEMENT AND BOND COVENANTS; DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO STRATEGIZE AND DEVELOP A FORWARD-LOOKING LONG-TERM PLAN TO PROVIDE FINANCIAL ASSISTANCE TO CONCESSIONAIRES AT MIAMI INTERNATIONAL AIRPORT DUE TO THE EFFECTS OF COVID-19; AND DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO PROVIDE REPORTS PURSUANT TO ORDINANCE NO. 14-65

WHEREAS, in December 2019, a novel coronavirus causing an infectious disease, named coronavirus disease 2019 (COVID-19) emerged; and

WHEREAS, with the illness spreading and the death toll rising around the world, on March 11, 2020, the World Health Organization (WHO) declared the outbreak a pandemic; and

WHEREAS, on March 13, 2020, President Donald J. Trump declared a national emergency and imposed travel restrictions between the United States and several countries around the world; and

WHEREAS, the United States Centers for Disease Control and Prevention (CDC) along with healthcare professionals worldwide have consistently stated that the best way to prevent illness is to avoid close person-to-person contact; and

WHEREAS, the travel restrictions along with the general public's adherence to the CDC's guidelines on physical distancing have resulted in a great reduction in passenger travel to and through Miami International Airport ("MIA"); and

WHEREAS, thereafter, many of the airport business partners requested deferrals or reductions in their monthly payments; and

WHEREAS, in response to these requests, on April 7, 2020, this Board passed Resolution No. R-332-20, which approved the adoption and implementation of financial relief plans for the County's business partners at MIA and the County's aeronautical business partners at the General Aviation Airports due to the effects of COVID-19 for a period of three months from March 1, 2020 through May 31, 2020, with one option to extend for an additional three months from June 1, 2020 through August 31, 2020, revocable upon a finding of a change in circumstances; and

WHEREAS, thereafter, this Board passed Resolution No. R-749-20, which amended Resolution No. R-332-20 extending the term of relief for certain concessionaires and one fixed-based operator at Miami International Airport, on a month-to-month basis from September 1, 2020 not to exceed December 31, 2020, subject to termination upon a finding of a change in circumstances; and

WHEREAS, the Miami-Dade Aviation Department (MDAD) continues to submit monthly reports to this Board detailing the grim circumstances that persist at MIA; and

WHEREAS, for example, MDAD's most recent July 2020 Relief Report provided a cumulative comparative analysis that showed an average decline of 79 percent in passenger flow levels at MIA for March 2019, April 2019, May 2019, June 2019 and July 2019 as compared to the same months in 2020, with the total number of domestic and international passengers falling from 19,592,694 passengers to 4,118,817 passengers, as well as a decline in total gross revenues for MIA concessionaires (including car rental agencies) of 77 percent, with revenues falling from \$398,712,211.00 to \$91,912,488.00 for the same time period; and

WHEREAS, based on certain shared information and the expectations of some air carriers at MIA, MDAD projects an average decrease of approximately 30 percent in passenger traffic flows in 2021; and

WHEREAS, because of the grim circumstances that persist, the forecasts that exist, and the unpredictability of the virus, it is important that MDAD develop a forward-looking long-term plan to assist concessionaires at MIA; and

WHEREAS, in the meantime, continued short term relief must be provided to assist certain business partners at MIA during these unprecedented times,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Amends Resolution No. R-332-20, as amended by Resolution No. R-749-20, relating to financial relief plans at Miami-Dade County's airports due to the effects of coronavirus disease 2019 (COVID-19), to extend the term of relief for 64 business partners at Miami International Airport (MIA) as listed in Exhibit A attached hereto, on a month-to-month

basis from January 1, 2021 to no later than April 30, 2021, for a total amount of \$32,996,656.00, subject to termination upon a finding of a change in circumstances. During the extended term, the Financial Relief Plan shall waive the Minimum Annual Guarantee (MAG) monthly payments, monthly rent, and other related fees for 64 business partners at MIA listed in Exhibit A, while still requiring payments based on a percentage of gross revenues. Notwithstanding its term, the Financial Relief Plan shall be subject to termination upon a finding of a change in circumstances, with such change fully set forth in monthly reports to this Board, detailing, at a minimum, passenger traffic and business productivity at MIA.

Section 2. Authorizes the County Mayor or County Mayor's designee to execute amendments to the agreements with the County's airport business partners listed in Exhibit A and to execute subsequent agreements necessary to effectuate the financial relief plans, provided that any relief authorized is (1) approved by the Federal Aviation Administration, and (2) in compliance with the Airport Amended and Restated Trust Agreement and Bond Covenants. Such amendments and subsequent agreements shall maintain their current provisions, including those enforcing releases of claims and requiring business partners to provide similar relief received to their subtenants and/or subcontractors.

Section 3. Directs the County Mayor or County Mayor's designee to continue to provide monthly reports to this Board regarding section 1 above, pursuant to Ordinance No. 14-65. Each report shall, at a minimum, detail the passenger traffic and level of business productivity at MIA since COVID-19's impact.

Section 4. Directs the County Mayor or County Mayor's designee to strategize and develop a forward-looking long-term plan to provide financial assistance to concessionaires at MIA due to the effects of COVID-19. Such plan shall at the very least explore potential changes

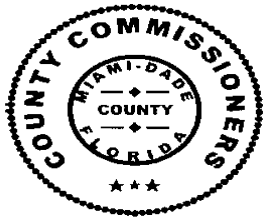
to existing concessionaire contracts and examine the impacts of passenger volumes in relation to revenues generated while ensuring compliance with rules of the Federal Aviation Administration, the Airport Amended and Restated Trust Agreement, and Bond Covenants.

Section 5. Directs the County Mayor or County Mayor’s designee to place a report on this Board’s agenda regarding section 4 above, pursuant to Ordinance No. 14-65 detailing the information in section 1 above within 120 days of this resolution.

The Prime Sponsor of the foregoing resolution is Acting Chairwoman Rebeca Sosa and the Co-Sponsor is Senator Javier D. Souto. It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The motion was seconded by Commissioner **Raquel A. Regalado** and upon being put to a vote, the vote was as follows:
