RESOLUTION NO. _____ R-1239-20

RESOLUTION AUTHORIZING THE PROVISION OF IN-KIND SERVICES FROM THE MIAMI-DADE POLICE DEPARTMENT AND THE MIAMI-DADE FIRE RESCUE DEPARTMENT IN AN AMOUNT OF \$320,000.00 TO SUPPORT THE 2021 COLLEGE FOOTBALL PLAYOFF NATIONAL CHAMPIONSHIP TO BE FUNDED FROM THE GENERAL FUND AND FIRE RESCUE DISTRICT FUNDS

WHEREAS, the 2021 College Football Playoff National Championship is a college football bowl game scheduled to determine a national champion in the NCAA Division I Football Bowl Subdivision (FBS) for the 2020 season; and

WHEREAS, it is planned to be played at Hard Rock Stadium in Miami Gardens, Florida, on January 11, 2021, with kickoff at 8:00 p.m. (EST) and television coverage by ESPN; and

WHEREAS, the College Football Playoff National Championship is annually one of the top-rated television events providing valuable branding and worldwide recognition for the host community; and

WHEREAS, in excess of 100,000 people are expected to visit the host community during the week of the College Football Playoff National Championship festivities; and

WHEREAS, South Florida has successfully hosted twenty College Football National Championships; and

WHEREAS, in recent years, South Florida hosted College Football National Championships (BCS National Championships) between #1-ranked Notre Dame and #2-ranked Alabama in 2013, #1-ranked Oklahoma and #2-ranked Florida in 2009, #1-ranked USC and #2-ranked Oklahoma in 2005, and #1-ranked Oklahoma and #2-ranked Florida State in 2001; and

WHEREAS, hosting this momentous sporting event in our community provides a tremendous opportunity to boost our tourism industry and local economy; and

WHEREAS, the 2021 College Football Playoff National Championship is expected to generate several hundred million dollars for our community; and

WHEREAS, the South Florida CFPNCG Host Committee, LLC (“Host Committee”), a Florida not-for-profit limited liability company, in partnership with the Orange Bowl Committee, has requested in-kind services from the Miami-Dade Police Department and the Miami-Dade Fire Rescue Department for the 2021 College Football Playoff National Championship and related activities; and

WHEREAS, the Board has recognized the significance of hosting this event when it approved the FY 2019-20 and FY 2020-21 budgets, which include additional funding in the amount of \$4,000,000.00 for the 2021 College Football Playoff National Championship; and

WHEREAS, the Board has previously shown its commitment to the 2001, 2005, 2009, and 2013 championships through grant funding and in-kind support of the championship and its surrounding activities,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board pledges Miami-Dade County’s assistance, subject to available resources, to implement the College Football Playoff National Championship.

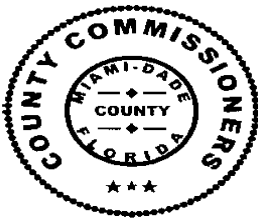
Section 2. This Board authorizes the Miami-Dade Police Department’s provision of public safety in-kind services at Hard Rock Stadium on game day for the 2021 College Football Playoff National Championship in the amount of \$150,000.00, and security and escort in-kind services for teams, bands, game officials, special guests, media, and merchandising in the amount of \$150,000.00, for a combined amount of \$300,000.00 to be funded from the General Fund.

Section 3. This Board authorizes the Miami-Dade Fire Rescue Department’s provision of in-kind services in the form of an emergency medical technician with a rescue unit at Hard Rock Stadium on game day for the 2021 College Football Playoff National Championship in the amount of \$20,000.00 to be funded from the Fire Rescue District Funds.

The Prime Sponsor of the foregoing resolution is Commissioner Jose “Pepe” Diaz. It was offered by Commissioner **José "Pepe" Diaz** , who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
