RESOLUTION NO. _____ R-1257-20

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR’S DESIGNEE TO: (1) EXPLORE OPPORTUNITIES TO PARTICIPATE IN INTERGOVERNMENTAL TRANSFERS WITH THE STATE OF FLORIDA AGENCY FOR HEALTH CARE ADMINISTRATION AS PART OF THE LOW INCOME POOL ON BEHALF OF BANYAN COMMUNITY HEALTH CENTER, INC., FOR THE PURPOSE OF EXPANDING HEALTH CARE SERVICES IN MIAMI-DADE COUNTY IN AN AMOUNT NOT TO EXCEED \$500,000.00; (2) EXPLORE ENTERING INTO ANY NECESSARY AGREEMENTS, INCLUDING A LETTER OF AGREEMENT WITH THE STATE OF FLORIDA AGENCY FOR HEALTH CARE ADMINISTRATION, SUBJECT TO BOARD APPROVAL, TO EFFECTUATE SAME; AND (3) PROVIDE A REPORT

WHEREAS, Banyan Community Health Center, Inc. (“Banyan”) is a not-for-profit healthcare organization dedicated to advancing the health and well-being of the South Florida community, and provides quality, integrated care that combines prevention, disease control, consumer education, research, and evidence-based clinical services; and

WHEREAS, Banyan is a Federally Qualified Health Center (FQHC) that receives federal government funds to provide primary health care services in underserved areas; and

WHEREAS, Banyan is also a centralized receiving facility for behavioral health crisis stabilization and serves as a coordinated entry point for persons with behavioral health or substance use disorders in Miami-Dade County; and

WHEREAS, Florida’s section 1115 Medicaid waiver created a Low Income Pool (LIP) to be used to provide supplemental payments to providers who provide services to Medicaid and uninsured patients; and

WHEREAS, the LIP program also authorizes supplemental Medicaid payments to certain provider access systems, such as FQHCs, to cover the cost of providing services to Medicaid recipients, the uninsured and the underinsured; and

WHEREAS, the LIP is funded through county and other local tax dollars that are transferred to the state and used to draw a federal match, which is known as “intergovernmental transfers” or IGTs; and

WHEREAS, counties participate in IGTs in the form of an executed Letter of Agreement with the Florida Agency for Health Care Administration (AHCA) containing the total amount of the IGT authorized no later than October 1 of each year, and are required to transfer the committed funds to AHCA no later than October 31; and

WHEREAS, this Board finds that exploring opportunities to participate in intergovernmental transfers with the State of Florida Agency for Health Care Administration on behalf of Banyan for the purpose of expanding health care services in Miami-Dade County is in the best interest of the County,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

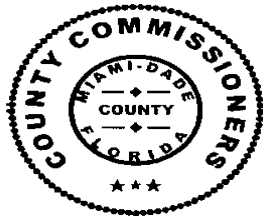
Section 1. Directs the County Mayor or County Mayor’s designee to: (1) explore opportunities to participate in intergovernmental transfers with the State of Florida Agency for Health Care Administration as part of the Low Income Pool on behalf of Banyan Community Health Center, Inc., for the purpose of expanding health care services in Miami-Dade County, in an amount not to exceed \$500,000.00; and (2) explore entering into any necessary agreements, including a letter of agreement with the State of Florida Agency for Health Care Administration, subject to Board approval, to effectuate same.

Section 2. Directs the County Mayor or County Mayor’s designee to prepare a report regarding the directives described in section 1, to include, at a minimum, a recommendation regarding possible participation in such intergovernmental transfers to the extent feasible, the required steps to finalize and execute any necessary agreements, the identification of available funds for this purpose, and the fiscal implications associated with same. The report shall be provided to this Board within 30 days of the effective date of this resolution, and shall be placed on an agenda of the Board pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Acting Chairwoman Rebeca Sosa. It was offered by Commissioner **José "Pepe" Diaz** , who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
