RESOLUTION NO. R-10-21

RESOLUTION CODESIGNATING THAT PORTION OF SW
172ND STREET FROM SW 100TH AVENUE TO SW 104TH
AVENUE AS “JOHNNY FLETCHER WAY”

WHEREAS, Johnny Fletcher (“Mr. Fletcher”), affectionately known as “Coach Peach,” dedicated much of his life to working with the youth in our community at the Richmond-Perrine Optimist Club (“RPOC”), an organization which provides sport and social service programs for children; and

WHEREAS, Mr. Fletcher began as a Recreation Leader with the RPOC in 1977, eventually becoming a coach and leading numerous youth softball and football teams to championship events throughout Florida; and

WHEREAS, through decades of work at the RPOC, many of the children and parents Mr. Fletcher interacted with came to recognize him not only as a coach, but also as a mentor, a friend, and a man who sacrificed his time for the betterment of the West Perrine neighborhood; and

WHEREAS, although Mr. Fletcher passed away on July 6, 2009, his impact on the community and those who participated in the RPOC’s programs will last for several generations; and

WHEREAS, this Board would like to honor the memory of Mr. Fletcher and his contributions to our community by codesignating that portion of SW 172nd Street from SW 100th Avenue to SW 104th Avenue as “Johnny Fletcher Way”; and

WHEREAS, that portion of SW 172nd Street from SW 100th Avenue to SW 104th Avenue is a County-maintained road located in unincorporated Miami-Dade County; and

WHEREAS, this proposed codesignation is located in County Commission District 9,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

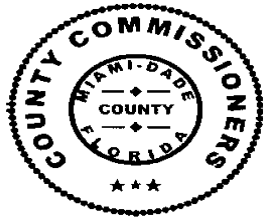
Section 1. Having considered this matter at a public hearing, codesignates that portion of SW 172nd Street from SW 100th Avenue to SW 104th Avenue as “Johnny Fletcher Way”.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Kionne L. McGhee. It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The motion was seconded by Commissioner **Kionne L. McGhee** and upon being put to a vote, the vote was as follows:
