Gaisha Tundra and Spirits Place, Inc.	\$ 1,500.00,

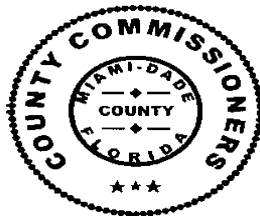
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
