(Installation of No Littering Signs in District 10) \$ 20,000.00,

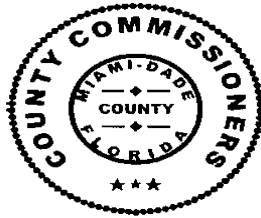
