RESOLUTION NO. R-244-21

RESOLUTION APPROVING THE CITY OF NORTH MIAMI
CODESIGNATION OF THAT PORTION OF NE 126TH STREET
FROM NE 8TH AVENUE TO NE 9TH AVENUE AS “DR.
GILBERT LEUNG WAY”

WHEREAS, Dr. Gilbert Leung has been a City of North Miami (“City”) resident for 31 years and has served as the City Physician for almost 30 years, since completing his Internal Medicine residency at the University of Miami; and

WHEREAS, Dr. Leung has since expanded his medical practice from a solo practitioner to three locations employing ten healthcare providers, in addition to establishing a dental office and an urgent care center; and

WHEREAS, Dr. Leung continues to be a devoted medical practitioner, good neighbor and greatly invested in our community as the owner of several properties within the City; and

WHEREAS, in recognition of his continuing dedication and commitment to the City and its residents, on August 25, 2015, the Mayor and City Council of the City of North Miami adopted Resolution No. 2015-R-82, which codesignated that portion of NE 126th Street from NE 8th Avenue to NE 9th Avenue as “Dr. Gilbert Leung Way”; and

WHEREAS, a copy of Resolution No. 2015-R-82 is attached hereto and incorporated by reference; and

WHEREAS, the City would like the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

WHEREAS, this Board would also like to recognize Dr. Leung’s continuing dedication and commitment to the City of North Miami and its residents by approving the City’s codesignation of that portion of NE 126th Street from NE 8th Avenue to NE 9th Avenue as “Dr. Gilbert Leung Way”; and

WHEREAS, NE 126th Street from NE 8th Avenue to NE 9th Avenue is a city-maintained road located in the City of North Miami; and

WHEREAS, this codesignation is located in County Commission District 2,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

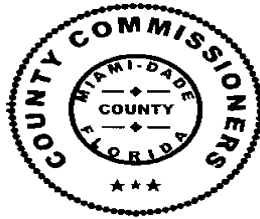
Section 1. Approves the City of North Miami’s codesignation of that portion of NE 126th Street from NE 8th Avenue to NE 9th Avenue as “Dr. Gilbert Leung Way”.

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor and City Council of the City of North Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the City of North Miami Police Department and the Miami-Dade Fire Rescue Department.

RESOLUTION NO. 2015-R-82

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, CO-DESIGNATING NORTHEAST 126TH STREET FROM NORTHEAST 8TH AVENUE TO NORTHEAST 9TH AVENUE TO BE KNOWN AS "DR. GILBERT LEUNG WAY"; AUTHORIZING THE CITY MANAGER TO ALLOCATE AND EXPEND THE REQUIRED FUNDS TO COVER THE COSTS FOR SIGNAGE, AND TO DO ALL THINGS NECESSARY TO EFFECTUATE THE CO-DESIGNATION; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, Dr. Gilbert Leung has been a City of North Miami ("City") resident for thirty-one (31) years and has served as the City Physician for almost thirty (30) years, since completing his Internal Medicine residency at the University of Miami; and

WHEREAS, Dr. Leung has since expanded his medical practice from a solo practitioner to three (3) locations employing ten (10) healthcare providers, in addition to establishing a dental office and an urgent care center; and

WHEREAS, Dr. Leung continues to be a devoted medical practitioner, good neighbor and greatly invested in our community as the owner of several properties within the City; and

WHEREAS, in recognition of his continuing dedication and commitment to the City and its residents, the Mayor and City Council wish to co-designate Northeast 126th Street from Northeast 8th Avenue to Northeast 9th Avenue to be known as "DR. GILBERT LEUNG WAY"; and

WHEREAS, the Mayor and City Council desire to authorize the City Manager to allocate and expend the necessary funds to cover the costs of any and all signs to indicate the designation of said street as "DR. GILBERT LEUNG WAY".

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of Street Co-Designation. The Mayor and City Council of the City of North Miami, Florida, hereby co-designate Northeast 126th Street from Northeast 8th Avenue to Northeast 9th Avenue to be known as "DR. GILBERT LEUNG WAY".

Section 2. Authorization of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to allocate and expend the required funds to cover the costs for signage, and do all things necessary to effectuate the co-designation.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
