Women's Fund of Miami-Dade, Inc.	\$ 1,500.00,

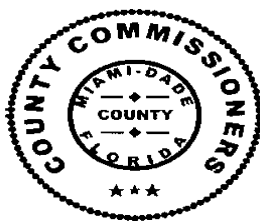
