Subject: Resolution Authorizing the County Mayor or County Mayor’s Designee to Seek Approval of the Plat of Pump Station 49 Located Within the City of Miami

Recommendation

It is recommended that the Board of County Commissioners (Board) approve this resolution delegating authority to the County Mayor or County Mayor’s Designee to seek approval by the City of Miami of the plat for the Miami-Dade Water and Sewer Department (MDWASD) Pump Station No. 49.

A location sketch is attached to this memorandum as Exhibit A.

Scope

The property to be platted is located in Commission District 3, which is represented by Commissioner Keon Hardemon.

Delegation of Authority

Authority is delegated to the County Mayor or County Mayor’s designee to apply to the City of Miami for approval of a plat within municipal boundaries and authorizes the County Mayor to sign the plat as property owner.

Fiscal Impact/Funding Source

The approval to delegate authorization in this resolution will not have a fiscal impact to Miami-Dade County.

Track Record/Monitor

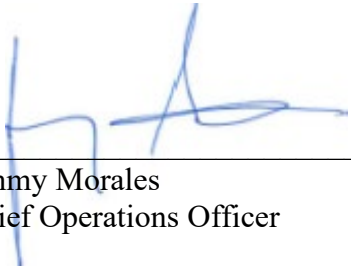
The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S. If this resolution is approved, the Planning and Development Division within the Miami-Dade Water and Sewer Department, will then seek approval of this plat with the City of Miami, and the person responsible for this function is Ramon R. Alba, P.E.

Background

The existing MDWASD Pump Station 49 is located in the middle of the residential street (NE 83rd Street), with a portion of the control panel within the clear zone on the south side of the roadway. The pump station is approximately 30-feet deep with the majority of the electrical controls on the first level below grade and was damaged during Hurricane Irma. Additionally, the existing pump station does not have a backup generator.

MDWASD is relocating Pump Station 49 from its existing location underneath NE 83rd Street between NE 9th Avenue and NE 10th Avenue to an acquired site located within the 899 NE 83rd Street property. The new Pump Station project will increase the capacity of the existing Pump Station 49 to accommodate future wastewater flows and to provide emergency power by incorporating a backup generator as required by the Department of Regulatory and Economic Resources for discharge force main equal to or greater than 12 inches in diameter. Pursuant to Florida Statutes section 177.071(1)(a), the City of Miami has jurisdiction over the subdivision of properties that are located wholly within its municipal boundaries.



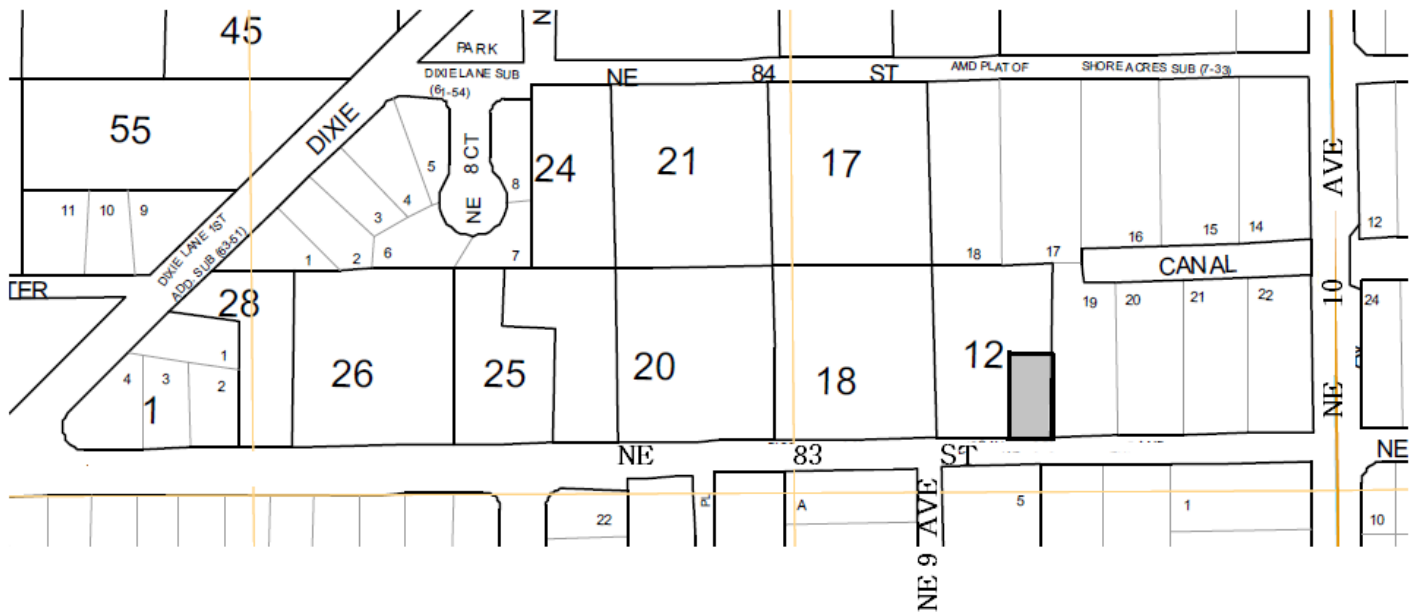

RESOLUTION AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO SEEK APPROVAL FOR A REPLAT OF CERTAIN PROPERTY LOCATED WITHIN THE CITY OF MIAMI; AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO TAKE ALL ACTIONS NECESSARY TO EFFECTUATE THE SAME

WHEREAS, Miami-Dade County owns certain property, identified as Exhibit A to the County Mayor's Memorandum, land lying wholly within the boundaries of the City of Miami; and

WHEREAS, the Miami-Dade County Water and Sewer Department intends to use the property as a proposed pump station; and

WHEREAS, pursuant to Florida Statutes section 177.071(1)(a), the City of Miami has jurisdiction over the subdivision of properties that are located wholly within its city limits; and

WHEREAS, the plat for Pump Station 49 requires the County Mayor's signature, on behalf of the county as owner, of the property in question, before the City of Miami can approve the final plat; and

WHEREAS, the Board of County Commissioners desires to facilitate the development of this site,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves and incorporates the foregoing recitals.

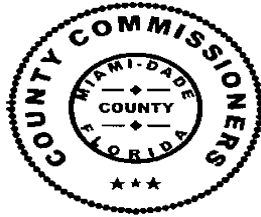
Section 2. Authorizes the County Mayor or County Mayor’s designee to apply to the City of Miami for the replat of the subdivided parcel of land, more particularly described by the following folio number: 01-3207-003-0025, as depicted in Exhibit A to the County Mayor’s Memorandum.

Section 3. Authorizes the County Mayor or the County Mayor’s designee to execute the plat as owner of the property and to perform all other acts necessary to effectuate the same.
