Iglesia Cristina de Misericordia, Inc. (Weekly Food Distribution)	\$ 3,500.00,

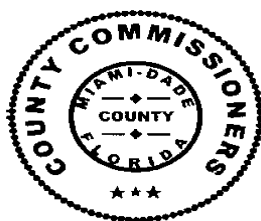
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
