Subject: Recommendation to Ratify Designated Purchase Award: Emergency Purchase and Installation of PCAs at the Miami International Airport (MIA)

Recommendation

It is recommended that the Board of County Commissioners (Board) approve this request for a designated purchase, pursuant to Section 2-8.1(b)(3) of the County Code, by a two-thirds vote of the Board members present, and ratify an emergency contract award, *Contract No. E-10128, PCA Purchase and Install Emergency* to Cavotec USA, Inc. (Cavotec) in the amount of \$1,107,738 for the Miami-Dade Aviation Department (MDAD).

Pre-conditioned air (PCA) units are needed to ensure passenger-loading bridges and aircrafts are sufficiently cooled while parked at gates. This purchase included five PCA units, accessories, hose management system, potable water cabinets, a converter with accessories and cable hoists, new electrical cables, installation, and startup services. Any additional work that would have been required, such as obtaining permits or performing electrical work would have been Cavotec's responsibility.

To meet the Miami International Airport (MIA) mid 2021 re-opening deadline and resumption of flight operations at MIA Concourses F and G, the Director of the Department declared an emergency on March 1, 2021 for an accelerated delivery of the units. It was imperative to the airport's economic recovery to have the PCA equipment operational, as it allowed for the accommodation of additional flights at these gates and the corresponding increased passenger volume being scheduled by MDAD's airline partners. Therefore, MDAD deemed the purchase and installation of five pre-conditioned air (PCA) units for gates F3, F5, F9, F11 and G14 as critical.

Competition was not practicable at the time due to the immediate need to purchase the equipment before the mid 2021 re-opening deadline. Additionally, this one-time purchase was awarded to Cavotec, the incumbent vendor that currently provides the maintenance, repair and replacement of parts and components of the PCA units installed at MIA, under current *Contract No. SS9863-1/26*. Furthermore, Cavotec owns the patents and proprietary rights to the software/hardware under contract No. SS9863-1/26 as well as the equipment for this designated purchase.

Staff performed due diligence by comparing pricing with other MDAD projects performed in recent months, as well as reaching out to Fort Lauderdale Airport to compare pricing for similar units. It was found that the pricing being offered by Cavotec is in line with other similar projects. It is in the County's best interest to approve ratification of this emergency award as the expedited purchase and installation of these units was critical and necessary for timely airport operations and well-being of MIA staff and patrons.

The availability of competition will be continually monitored so that the need for future designated purchases is reduced or eliminated as soon as practicable. Accordingly, it is in the County's best interest to approve this designated purchase pursuant to Section 2-8.1(b)(3) of the Miami-Dade County Code to ratify the purchase of these PCA units.

Scope

Miami International Airport is located within District 6, which is represented by Commissioner Rebeca Sosa; however, the impact of this item is countywide.

Delegated Authority

If this item is approved, the County Mayor or County Mayor's designee will have the authority to exercise all provisions of the contract, including any cancellation, renewal or extension provisions, pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38.

Fiscal Impact/Funding Source

The fiscal impact of this emergency purchase is \$1,107,738.

RESOLUTION AUTHORIZING A DESIGNATED PURCHASE PURSUANT TO SECTION 2-8.1(B)(3) OF THE COUNTY CODE BY A TWO-THIRDS VOTE OF THE BOARD MEMBERS PRESENT; RATIFYING AN EMERGENCY PURCHASE FOR THE MIAMI-DADE AVIATION DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$1,107,738.00 FOR PCA PURCHASE AND INSTALL EMERGENCY, CONTRACT NO. E-10128; AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO EXERCISE ALL PROVISIONS OF THE CONTRACT, INCLUDING ANY CANCELLATION, RENEWAL OR EXTENSION PROVISIONS, PURSUANT TO SECTION 2-8.1 OF THE COUNTY CODE AND IMPLEMENTING ORDER 3-38

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board finds it is in the best interest of Miami-Dade County to award Contract No. E-10128, for PCA Purchase and Install Emergency, as a designated purchase in an amount not to exceed \$1,107,738.00 for the Miami-Dade Aviation Department, pursuant to Section 2-8.1(b)(3) of the Code of Miami-Dade County, by a two-thirds vote of the Board members present.

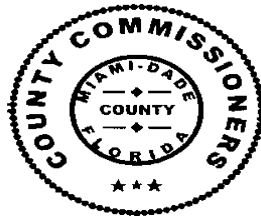
Section 2. This Board ratifies an emergency purchase authority in an amount not to exceed \$1,107,738.00 for the Miami-Dade Aviation Department for PCA Purchase and Install Emergency, Contract No. E-10128 as set forth in the incorporated memorandum.

Section 3. This Board authorizes the County Mayor or County Mayor’s designee to exercise all provisions of the contract, including any cancellation, renewal or extension provisions, pursuant to Section 2-8.1 of the Code of Miami-Dade County, Florida and Implementing Order 3-38. Copies of the contract document are on file with and available upon request from the Internal Services Department, Strategic Procurement Division.
