Subject: Eleventh Judicial Circuit of Florida's Miami-Dade County Mental Health Awareness Training for Criminal Justice Stakeholders Project Grant Application

Recommendation

It is recommended that the Board of County Commissioners (Board) approve this item, which does the following:

- Retroactively authorizes the County Mayor or the County Mayor's designee's action, acting as the fiscal agent for the Eleventh Judicial Circuit of Florida (Court) pursuant to Resolution No. R-79-03, in applying for grant funds from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA), in the amount of \$625,000.00 for the Miami-Dade County Mental Health Awareness Training for Criminal Justice Stakeholders Project (Project).
- Authorizes the County Mayor or the County Mayor's designee, as fiscal agent for the Court, to execute any amendments to the grant application; to receive any grant funds that are awarded in response to this application; to execute such contracts, agreements, memoranda of agreements, and amendments as may be required by program guidelines for the Project; and, to exercise termination and modification clauses of any such contracts and agreements, all of which are subject to the County Attorney's Office's approval for form and legal sufficiency.
- Authorizes the County Mayor or the County Mayor's designee, as fiscal agent for the Court, to apply for and receive additional future funds that may become available for the Project; to execute such contracts, agreements, memoranda of agreements, and amendments as may be required by the County to act as fiscal agent for the Court with respect to such future available funds, after review by the County Attorney's Office for form and legal sufficiency; and to exercise termination and modification clauses of any such contracts and agreements, subject to the County Attorney's Office's approval for form and legal sufficiency.

Scope

Miami-Dade County (County), through the Office of Management and Budget, Grants Coordination Division (OMB-GCD), on behalf of the Court, applied for a grant from SAMHSA in the amount of \$625,000.00 for the Miami-Dade County Mental Health Awareness Training for Criminal Justice Stakeholders Project as noted in Attachment A. The Court, as lead partner, formed a collaborative partnership with the Office of the Public

Defender; Office of the State Attorney; Miami-Dade Corrections and Rehabilitation Department; Florida Department of Corrections; National Alliance of Mental Illness of Miami; Camillus House; Community Health of South Florida Inc.; and Jackson Behavioral Health Hospital (collectively, criminal justice stakeholders), to implement the Project. The goal of the Project is to improve mental health awareness for criminal justice stakeholders and will involve training criminal justice stakeholders on how to appropriately and safely respond to individuals identified with serious mental illnesses and co-occurring substance use disorders. The Project will train 375 individuals annually and 1,875 individuals over the 5-year Project period.

Delegation of Authority

The County Mayor or County Mayor’s designee is retroactively authorized to act as the fiscal agent for the Court in submitting the grant application for the Project. In addition, the County Mayor or County Mayor’s designee is authorized to: execute any amendments to the grant application; receive grant funds; execute such contracts, agreements, memoranda of agreements, and amendments as may be required by program guidelines for the Project and to exercise termination and modification clauses of any such documents; and to apply for and receive additional future funds that may become available for the Project; to execute such contracts, agreements, memoranda of agreements, and amendments as may be required with respect to such future available funds for the Project and to exercise termination and modification clauses of any such documents.

Fiscal Impact/Funding Source

The grant request is for \$625,000.00. There is no fiscal impact to the County to serve as the fiscal agent of the Court for this grant project. The Project does not require matching funds.

Track Record/Monitor

The OMB-GCD and the Eleventh Judicial Circuit have an extensive history of managing grant projects and will coordinate Project implementation and management. OMB-GCD will monitor the Project and serve as liaison with the SAMHSA. The Court will handle project drawdowns through SAMHSA, in concert with the County’s Finance Department; process the disbursement and expenditure of grant funds; and manage programmatic and fiscal reporting in accordance with Project reporting and auditing procedures stipulated by SAMHSA.

Background

The over representation of individuals identified with serious mental illnesses and co-occurring substance use disorders involved in the criminal justice system is well documented. In Miami-Dade County, approximately 70 percent of individuals who live with serious mental illness or substance use disorder are not currently receiving treatment.

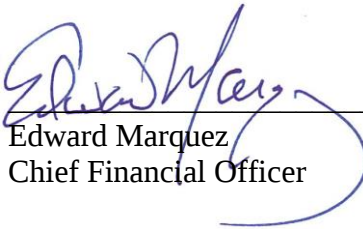
The Court will implement the Project to improve mental health awareness for criminal justice stakeholders. The Project will train criminal justice stakeholders to recognize the signs and symptoms of serious mental illness as well as learn skills to de-escalate potential volatile interactions with individuals with mental illness. Stakeholders will include the above-mentioned law enforcement officers, court employees, correctional staff, attorneys, social

service partners and families. Crisis Intervention Team training and Mental Health First Aid will be utilized as evidence-based practices. Mental Health Awareness training will focus on how to recognize the signs and symptoms of mental illness and how to respond to crisis situations safely and appropriately. Training will cover effective communication techniques, de-escalating crises, promoting mental health literacy, reducing stigma of mental illness, enabling early intervention through recognition of signs and symptoms, and connecting people to care. The Project Application is provided as an attachment to this memorandum.

The short turnaround time imposed by SAMHSA’s application deadline did not allow sufficient time for the processing of the resolution and its submission to the Board prior to submission of the grant application.

Miami-Dade County Mental Health Awareness Training for Criminal Justice Stakeholders

Section A. Population of Focus

A1. Miami-Dade County, on behalf of The Eleventh Judicial Circuit Criminal Mental Health Project (CMHP), proposes to develop and implement the project entitled, *Mental Health Awareness Training for Criminal Justice Stakeholders*. There is a tremendous need for increased mental health awareness for individuals that interact and encounter persons who may be experiencing or exhibiting symptoms of serious mental illnesses (SMI) that are at risk of or involved in the criminal justice system. The project is designed to prepare and train criminal justice partners to appropriately and safely respond to individuals identified with SMI and co-occurring substance use disorders (SUD). Upon entry into the criminal justice system and incarceration, individuals with SMI and co-occurring SUD interact with a wide variety of stakeholders involved in the criminal justice system. This population is often misunderstood, alienated, and stigmatized. Training on how to recognize the signs and symptoms of mental illnesses and how to respond safely and appropriately will benefit both people with mental illnesses and substance use disorders and criminal justice stakeholders.

Stakeholders may include law enforcement, court employees, correctional staff, attorneys, social service partners, and families. Evidence-based training including Crisis Intervention Team (CIT) for law enforcement partners and Mental Health First Aid (MHFA) for other partners will provide the knowledge base and skills to increase mental health awareness. Training will cover effective communication techniques, de-escalating crises, promoting mental health literacy, reducing the stigma of mental illnesses, enabling early intervention through recognition of signs and symptoms of the onset of mental illnesses and substance use disorders, and connecting people to the healthcare system.

The geographic catchment area where training and services will be delivered is Miami-Dade County, Florida. It is in the southeastern part of the United States in the State of Florida. According to a 2019 census report, Miami-Dade County has a multi-ethnic and multi-racial population of 2,716,940 people, making it the most populous county in Florida and the seventh-most populous county in the United States. The Eleventh Judicial Circuit of Florida is the largest court system in Florida and the 4th largest court system in the nation. In addition, Miami-Dade County has 36 police municipalities.

A2. The over representation of individuals identified with serious mental illnesses and co-occurring substance use disorders involved in the criminal justice system is well documented. In Miami-Dade County, approximately 70% of individuals who live with SMI or SUD receive no treatment. As a result, police officers have increasingly become the first, and often only, responders to people in crisis due to untreated mental illnesses. Too often, these encounters result in the arrest and incarceration of individuals for criminal offenses that are directly related to individuals' psychiatric symptoms and/or life-health contexts e.g., homelessness, addiction, poverty.¹

The Miami-Dade County jail currently serves as the largest psychiatric institution in Florida and contains as many beds serving inmates with mental illness as all state civil and forensic mental

health treatment facilities combined. Jackson Health Systems' Corrections Health Services, which provides health care services in the county jail, reports that in 2020 approximately 2,200 of the 3,700 individuals housed in the county jail on any given day (60%) are classified as having some mental health treatment need. Based on a total per diem cost of \$265 per bed, the estimated cost to taxpayers is \$636 000 per day, or more than \$232 million per year. Upon reentry to the community from jail, access to community resources such as treatment, supportive services, and housing are extremely difficult to navigate.

Section B: Proposed Implementation Approach

B1. Nearly two-thirds of the inmates housed in the Miami-Dade County jail have identified mental health needs. As such, there is a tremendous need for increased mental health awareness for criminal justice stakeholders that interact and encounter people who may be experiencing or exhibiting symptoms of serious mental illnesses. Mental health disorders are diagnosable illnesses that are characterized by alterations in thinking, mood or behavior which can be associated with distress and the inability to function in daily activities. There are many myths and misunderstandings about mental health issues that may result in denial, avoidance or exacerbation of symptoms that can lead to escalation of potentially volatile situations. Justice system stakeholders are generally not well informed about how to recognize mental health problems, how to most effectively respond to individuals experiencing acute distress, or what effective treatments might be available. With greater understanding and knowledge, criminal justice stakeholders will be able to recognize the signs and symptoms of mental illnesses and be better prepared to de-escalate unusual or threatening behaviors, offer support, and provide information about community resources. Stakeholders include law enforcement, court employees, correctional staff, attorneys, social service partners and families.

The goal of the project is to increase mental health awareness for criminal justice stakeholders. The objectives to reach the desired goal are as follows.

1. Beginning December 2021 provide Crisis Intervention Team training to 225 law enforcement officers annually for the duration of the grant program (1,125 total for 5 years).
2. Beginning December 2021 provide Mental Health First Aid training to 150 stakeholders (i.e., attorneys, court employees, correctional personnel, homeless providers, families) annually for the duration of the grant program (750 total for 5 years).
3. Beginning December 2021 collect data monthly to demonstrate numbers of individuals trained, trainings provided and referrals to mental health services.
4. Beginning September 2021, establish on-going communication, collaboration, and partnerships among all relevant county partners with respect to people with mental illnesses, and co-occurring SUD who are in, or at risk of entering, the criminal justice systems

B2. The project is designed to prepare and train criminal justice partners to appropriately and safely respond to individuals identified with SMI and co-occurring SUD. The population of focus for the project encompasses a wide range of stakeholders that are culturally and professionally diverse.

The 5 largest ethnic groups in Miami-Dade County are White (Hispanic) 61.5%, Black or African American, (Non-Hispanic) 15.5%, White (Non-Hispanic) 12.9%, other (Hispanic) 4.59%, and Black or African American (Hispanic) 1.66%. Both CIT and MHFA were selected as the evidence-based practices to be used for increasing mental health awareness because they address the diverse needs of the target groups. Criminal Justice stakeholders are not mental health professionals and cannot provide clinical screening, assessment, or treatment. The training will provide the basic knowledge of mental health problems, skills, and techniques to de-escalate emergent situations and the framework necessary to help immediately.

Planning activities will begin upon the grant award. The Project Director and the CIT Coordinator both have many years of experience as CIT and MHFA instructors as well as management experience executing training programs. This will enable a smooth transition to program implementation by the fourth month of the grant. The Mental Health Trainer will be hired and provided with opportunities to learn the necessary skills including Mental Health First Aid Instructor training, CIT Coordinator Training and First Force de-escalation training. Evaluation and resource materials will be identified and printed. Other training materials will be purchased in the planning phase. Project partners will be notified to schedule, identify locations, and select participants for trainings. CIT training for law enforcement will be scheduled to begin with one class per month (25 participants) to equal 9 classes in the first year (225). MHFA training will also begin in the fourth month of the grant with a class (25 participants) and provided 6 times annually to equal 150 participants in the first year.

Identifying resources and community support are an important component of mental health awareness training. The CIT training curriculum includes a segment on community mental health and substance use disorders resources that teaches law enforcement about how to access local treatment and services. According to Florida's civil mental health commitment statutes, also known as the Baker Act, a law enforcement officer shall take a person who appears to meet the criteria for involuntary examination into custody and deliver the person or have him or her delivered to an appropriate, or the nearest, facility within the designated receiving system for examination. The Baker Act further requires a law enforcement officer who has custody of a person based on either non-criminal or minor criminal behavior that meets the statutory guidelines for involuntary examination to transport the person to the nearest and most appropriate receiving facility for examination, instead of to jail. See section 394.462, Florida Statutes.

Individuals who participate in MHFA will be provided with a companion manual based on the developed guidelines for recognizing the signs and symptom of mental illnesses as well as a plan of action for mental health emergencies. All CIT and MHFA participants will receive key resources for public distribution. Electronic access to The Consumer and Family Resource Manual (November 2020) for Miami-Dade and Monroe Counties; a comprehensive guide to behavioral health resources, a CIT Brochure, that includes information on CIT and essential 24/7 resources such as the Mobile Response Team, NAMI, crisis/suicide hotline, etc. and a wallet-size card with the resource contacts provided in the CIT brochure.

Utilizing mental health and community resource information obtained from CIT training, law enforcement will screen and assess individuals encountered and determine need for referral to treatment. Information will be collected and tracked from law enforcement agencies that have provided commitment to the project. Tracking information about referrals for treatment will be received monthly and will include numbers of mental health calls, number of involuntary

examinations, number of individuals diverted to treatment in lieu of arrest, and number of referrals to outpatient treatment.

A survey tool will be developed for MHFA participants to collect and track information from participants regarding satisfaction, use of the resources and referrals to treatment. The survey will be delivered at one- and three-months post training.

This proposal represents a collaborative effort among stakeholders in the criminal justice and behavioral healthcare systems in Miami-Dade County. Support for the project is comprehensive and widespread throughout the community. There are 16 letters of commitment from partnering organizations. The Eleventh Judicial Circuit of Florida, Administrative Office of the Courts will provide court employees for the training as well as in-kind support for the Project Director and CIT Coordinator Position.

Jackson Behavioral Health Hospital (JBHH) and Community Health of South Florida, Inc. (CHI) have provided commitments to partner on this project as licensed mental health providers. This is geographically advantageous as JBHH covers north and central Miami-Dade County and CHI covers the southern part of the county.

Jackson Health System is a publicly funded organization and the safety net healthcare provider for Miami-Dade County residents. JBHH is a free-standing hospital consisting of 239 beds treating adults, geriatric, child and adolescent and patients with mental health, substance use, and co-occurring disorders. The hospital also has an emergency/intake and referral center. In addition, the hospital has two outpatient locations and a crisis stabilization facility in northern Miami-Dade County. As a committed partner, Jackson will accept referrals for mental health treatment and services. Community Health of South Florida, Inc. a federally qualified health center which includes crisis stabilization and outpatient behavioral healthcare will accept referrals in the south Miami-Dade County area.

The Substance Abuse and Mental Health (SAMH) Program Office of the Florida Department of Children and Families, which contracts with Thriving Mind South Florida to manage the SAMH system of care, will also support this project. Thriving Mind ensures that quality and best practices are provided to consumers and families seeking services in Miami-Dade and Monroe Counties. The Consumer and Family Resource Manual (November 2020) for Miami-Dade and Monroe Counties is a comprehensive guide to behavioral health resources that can be accessed electronically at www.thrivingmind.org and will be provided to all training participants.

The Dade-Miami Criminal Justice Council will also serve as a resource to the project. The Council's purpose is to encourage and facilitate coordination and cooperation between and among the various agencies of the Criminal Justice System of Miami-Dade County and to provide advice, analysis, and technical assistance to criminal justice-related agencies. As part of the Council, The Public Safety Coordinating Council (PSCC) Committee is charged with carrying out the duties required by Florida State law. The PSCC meets quarterly and the composition of the group includes all the necessary leadership to be in compliance with Florida Statue 394.657(2)(a). Upon notice of the grant award, the PSCC will be notified and an agenda item will be added to the quarterly meeting for the entirety of the grant.

Section C: Proposed Evidence-Based Service/Practice

The Crisis Intervention Team (CIT) Memphis Model will be utilized as the evidenced-based practice (EBP) for the mental health awareness training for law enforcement. This 40-hour specialized course provides law enforcement-based crisis intervention training designed to assist individuals with mental illnesses and/or those who are in mental health crisis. CIT training educates and prepares officers to recognize the signs and symptoms of mental illnesses, the impact the behaviors and perceptions of individuals and how to respond effectively to people in crisis. No modifications are necessary to this curriculum.

CIT improves safety, reduces stigma, and redirects individuals with mental illnesses and/or substance use disorders from the criminal justice system to the health care system. Training modules include psychiatric disorders, suicide intervention, substance use conditions, de-escalation techniques, trauma, perspective of persons in recovery, site visits, legal aspects, and community behavioral health resources.²

There is evidence for officer outcomes, such as officer satisfaction and perception of a reduction in the use of force. A survey of police officers indicated that CIT-trained officers perceived themselves as less likely to escalate to the use of force in a hypothetical mental health crisis

encounter. There is also evidence for CIT's effect on prebooking jail diversion. One study, which involved 180 officers (roughly 50% CIT-trained) from multiple departments and reported on 1,063 incidents, demonstrated a CIT effect of increased verbal negotiation as the highest level of force used, with referral to mental health units more likely and arrest less likely.²

Compared with non-CIT officers, CIT-trained officers had greater knowledge about mental illnesses and their treatments, better attitudes (across 17 different domains), greater self-efficacy, lesser stigma, better de-escalation decisions, and better referral decisions.³

To further enhance de-escalation skills within CIT training, police officers will learn Force Science Institute's (FSI) Realistic De-escalation Techniques. FSI promotes the value of knowledge through empirical research in behavioral science and human dynamics and offers police officers the methods necessary to communicate and de-escalate a crisis. Scenario-based instruction allow for officers to practice de-escalation techniques in a safe environment and process the experience while receiving guidance and feedback.

Training outcomes will aim to equip police officers with the tools, resources, skills, and knowledge necessary to respond to a person in crisis safely and effectively. Officers will develop greater understanding of mental illnesses and substance disorders, how to navigate through the system of care, and refer and link individuals to appropriate resources. Police officers will gain awareness of the scientific principles and methods of de-escalation techniques, conflict resolution strategies, and how to apply these strategies. Anticipated outcomes include reduced arrest of people with mental illnesses, decreased use of force, increased diversion to treatment and services, and an overall improvement in officer attitudes and perceptions of individuals with mental illnesses.

Other criminal justice stakeholders will be presented with Mental Health First Aid training. Peer reviewed studies demonstrate that individuals trained have increased their knowledge of the signs and symptoms and risk factors of mental illness and addictions. This approach takes the fear and hesitation out of starting conversations about mental health and substance use disorders by improving understanding and providing an action plan that teaches people to safely and responsibly identify and address a potential mental illnesses or substance use disorders. No modifications to the curriculum will be necessary.

MHFA is a public education program that introduces participants to risk factors and warning signs of mental illnesses, builds understanding of their impact, and reviews common supports. The 8-hour course uses role-playing and simulations to demonstrate how to offer initial help in a mental health crisis and connect persons to the appropriate professional, peer, social, and self-help care. This includes de-escalation exercises and examples. The program also teaches the common risk

factors and warning signs of specific types of illnesses like anxiety, depression, substance abuse and dependence, bipolar disorder, eating disorders, and schizophrenia.

Mental Health First Aid is included on the Substance Abuse and Mental Health Services Administration's National Registry of Evidence-based Programs and Practices (NREPP). It teaches participants a five-step action plan, ALGEE, to support someone demonstrating signs and symptoms of a mental illness or in an emotional crisis:

- Assess for risk of suicide or harm
- Listen nonjudgmentally
- Give reassurance and information
- Encourage appropriate professional help
- Encourage self-help and other support strategies

Like CPR, Mental Health First Aid prepares participants to interact with a person in crisis and connect the person with help. First Aiders are not trained to be clinical professionals, they do not diagnose or provide any counseling or therapy. Instead, the program offers concrete tools and answers key questions like, "what do I do?" and "where can someone find help?" Certified Mental Health First Aid instructors provide a list of community healthcare providers and national resources, support groups, and online tools for mental health and addictions treatment and support. All trainees receive a program manual to compliment the course material.

Section D: Staff and Organizational Experience

D1. The CMHP has more than twenty years of successful experience with project development, grant implementation, and sustainability with partnering organizations. It was established in 2000 to divert individuals with SMI or co-occurring SMI and substance use disorders away from the criminal justice system and into comprehensive community-based treatment and support services. The program operates two primary components: pre-booking jail diversion consisting of Crisis Intervention Team (CIT) training for law enforcement officers and post-booking jail diversion serving individuals booked into the county jail and awaiting adjudication. Since 2003, there have been more than 7,600 law enforcement officers trained in CIT. In addition, the CMHP offers a variety of overlay services intended to: streamline screening and identification of program participants; develop evidence-based community reentry plans to ensure appropriate linkages to community-based treatment and support services; improve outcomes among individuals with histories of noncompliance with treatment; and expedite access to federal and state entitlement benefits.

The CMHP provides an effective, cost-efficient solution to a community problem and works by eliminating gaps in services and forging productive and innovative relationships among all stakeholders who have an interest in the welfare and safety of one of our community's most vulnerable populations.

Identified partners for the proposed project include the Miami-Dade County Public Defender's Office, Miami-Dade County State Attorney's Office, Miami-Dade Corrections and Rehabilitation Department, Florida Department of Corrections, NAMI of Miami, Camillus House, CHI, and Jackson Behavioral Health Hospital. These organizations will receive Mental Health First Aid training and will commit to provide individuals for training as well as collect necessary

performance data. Other identified partners include 8 law enforcement departments including Miami Police Department (PD), Doral PD, Homestead PD, South Miami PD, Miami Beach PD, Miami Gardens PD, Miami-Dade School PD and Aventura PD. These departments will commit to provide officers for CIT training, will collect data as necessary, and provide training sites.

The Jackson Behavioral Health Hospital has provided commitment to partner on this project as a licensed mental health provider. Jackson Behavioral Health Hospital has served the community for more than 20 years. As one of the largest and most comprehensive public-academic psychiatric programs in the United States, Jackson Behavioral Health Hospital offers an array of interdisciplinary mental health and substance abuse services delivered in a full continuum of care within hospital, community, and transitional settings, including emergency, inpatient, outpatient, and residential programs. In addition, Community Health of South Florida, Inc. (CHI) has also committed to participate on this project as a licensed mental health provider. CHI is a nonprofit health care organization providing affordable quality primary and behavioral health care services to residents of South Florida.

D2. Key personnel

Project Director- Cindy A. Schwartz, MS, MBA, 20% effort, provides administration, management, and supervision of the CMHP as well as general oversight of the expansion and enhancement of all program activities. Her career goals have been focused on promoting system transformation, community integration and recovery for individuals who experience serious mental illnesses. Ms. Schwartz has a master's degree in Rehabilitation Counseling from the State University of New York at Buffalo and a master's degree in Business Administration from Nova Southeastern University. She is a certified Mental Health First Aid Instructor, an Advanced WRAP (Wellness Recovery Action Plan) facilitator, Instructor of How Being Trauma Informed Improves Criminal Justice Responses, Certified Court Manager, on the National Expert Panel for SSI/SSDI Outreach, Access, and Recovery Technical Assistance (SOAR TA) Center and consultant for the SAMHSA GAINS Center. Ms. Schwartz is also actively involved in her community and serves on a variety of professional organizations, boards, and committees.

Habsi W. Kaba MS, MFT, CMS, 50% effort, oversees the Crisis Intervention Team (CIT) program for 36 law enforcement agencies, partners, and stakeholders in Miami-Dade County. She is a certified Florida Department of Law Enforcement Criminal Justice Professional Program Instructor, a certified Mental Health First Aid USA Instructor, CIT Master Instructor and Instructor of How Being Trauma informed Improved Criminal Justice Responses. Ms. Kaba has trained over 15,000 law enforcement/first responders, criminal justice stakeholders, educators, medical and social service professionals. She has served as a consultant for government agencies, including de-escalation instruction for the Department of Homeland Security U.S. ICE Hostage Negotiation Team. Ms. Kaba serves on the Crisis Intervention Team (CIT) International Board of Directors and is a recognized expert in the field of crisis intervention, curriculum design, trauma, officer wellness, de-escalation, and police mental health collaboration.

Mental Health Trainer- 100% effort, to be hired, Coordinate and facilitate Crisis Intervention Team (CIT) and Mental Health First Aid (MHFA) trainings for the SAMHSA Mental Health Awareness Training Grant.

The project collects extensive information to effectively manage operations and make program adjustments as necessary. Systems-level performance and outcome data is collected and analyzed on a regular basis to measure effectiveness and efficiency as well as to identify opportunities and barriers.

The proposed project will collect all information necessary to meet requirements and to demonstrate alignment with project goals and objectives. An application for data collection and reporting will be developed by the court IT department. Information will be collected at each training, compiled monthly and reviewed by key personnel. Data to be collected includes:

- Number of participants
- Gender and race of participants
- Contact information for participants
- Partner organizations represented
- Resources provided
- Evaluation submitted

CIT Data to be tracked for 3 months following training

- Number of MH calls
- Number of involuntary examinations pursuant to state mental health civil commitment laws
- Number of involuntary examinations pursuant to state substance use civil commitment laws
- Number of individuals diverted to treatment (in lieu of arrest)
- Number of referrals for outpatient treatment

In addition, a survey tool will be developed to collect information from participants regarding satisfaction, resources and referrals. The survey will be collected at intervals of one- and three-months following the training.

The Miami-Dade County Mental Health Awareness Training for Criminal Justice Stakeholders is designed to prepare and train criminal justice partners on how to appropriately and safely respond to individuals identified with serious mental illnesses (SMI) and co-occurring substance use disorders (SUD). The goal of the project is to improve mental health awareness for criminal justice stakeholders. The objectives of the project will be to train criminal justice stakeholders to recognize the signs and symptoms of SMI as well as learn skills to de-escalate potential volatile interactions. Stakeholders will include law enforcement, court employees, correctional staff, attorneys, social service partners and families. Crisis Intervention Team (CIT) training and Mental Health First Aid (MHFA) will be utilized as the evidence-based practice. The project will train 375 stakeholders annually and 1,875 over the 5-year grant period.

The over representation of individuals identified with serious mental illnesses and co-occurring substance use disorders involved in the criminal justice system is well documented. In Miami-Dade County, approximately 70% of individuals who live with serious mental illness (SMI) or substance use disorder (SUD) are currently not receiving treatment. As a result, police officers have increasingly become the first, and often only, responders to people in crisis due to untreated mental illnesses. Too often, these encounters result in the arrest and incarceration of individuals for criminal offenses that are directly related to individuals' psychiatric symptoms and/or life-health contexts (e.g., homelessness, addiction, poverty).

Upon entry into the criminal justice system and incarceration, individuals with SMI and co-occurring SUD will interact with a wide variety of people. This population is often misunderstood, alienated and stigmatized. Mental Health Awareness training on how to recognize the signs and symptoms of mental illness and how to safely and appropriately respond will benefit everyone involved. Training will cover; effective communication techniques, de-escalating crises, promoting mental health literacy, reducing stigma of mental illness, enabling early intervention through recognition of signs and symptoms, and connecting people to care.

Community resources to mental health service agencies and other appropriate resources will be provided to all participants of Mental Health Awareness training. In addition, referrals to mental health resources and services will be tracked through the data collection process.

RESOLUTION RETROACTIVELY AUTHORIZING THE ACTION OF THE COUNTY MAYOR OR THE COUNTY MAYOR'S DESIGNEE, ACTING AS FISCAL AGENT FOR THE ELEVENTH JUDICIAL CIRCUIT OF FLORIDA, AS AUTHORIZED BY RESOLUTION NO. R-79-03, IN APPLYING FOR GRANT FUNDS FROM THE UNITED STATES DEPARTMENT OF HEALTH AND HUMAN SERVICES, SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION, IN THE AMOUNT OF \$625,000.00 FOR THE MIAMI-DADE COUNTY MENTAL HEALTH AWARENESS TRAINING FOR CRIMINAL JUSTICE STAKEHOLDERS PROJECT (PROJECT); AUTHORIZING THE COUNTY MAYOR OR THE COUNTY MAYOR'S DESIGNEE, ACTING AS FISCAL AGENT FOR THE ELEVENTH JUDICIAL CIRCUIT OF FLORIDA, TO EXECUTE AMENDMENTS TO THE GRANT APPLICATION, TO RECEIVE ANY GRANT FUNDS THAT ARE AWARDED, AND TO EXECUTE SUCH CONTRACTS, AGREEMENTS, AND MEMORANDA OF AGREEMENT THAT MAY BE NECESSARY FOR THE PROJECT, AND TO EXERCISE TERMINATION AND MODIFICATION PROVISIONS CONTAINED THEREIN; AND AUTHORIZING THE COUNTY MAYOR OR THE COUNTY MAYOR'S DESIGNEE, AS FISCAL AGENT FOR THE ELEVENTH JUDICIAL CIRCUIT OF FLORIDA, TO APPLY FOR AND RECEIVE ADDITIONAL FUTURE FUNDS THAT MAY BECOME AVAILABLE FOR THE PROJECT AND TO EXECUTE ANY CONTRACTS, AGREEMENTS, OR MEMORANDA OF AGREEMENT THAT MAY BE NECESSARY FOR THE RECEIPT OF SUCH FUTURE AVAILABLE FUNDS, AND TO EXERCISE TERMINATION AND MODIFICATION PROVISIONS CONTAINED THEREIN

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The matters contained in the foregoing recital and the accompanying County Mayor's memorandum are incorporated in this resolution by reference.

Section 2. This Board retroactively authorizes the action of the County Mayor or the County Mayor's designee, acting as the fiscal agent for the Eleventh Judicial Circuit of Florida, and as authorized by Resolution No. R-79-03, in applying for grant funds from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, in the amount of \$625,000.00 for the Miami-Dade County Mental Health Awareness Training for Criminal Justice Stakeholders Project (Project).

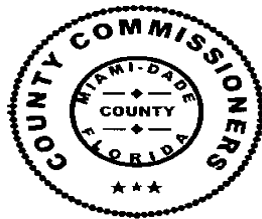
Section 3. This Board authorizes the County Mayor or the County Mayor's designee, acting as the fiscal agent for the Eleventh Judicial Circuit of Florida, to execute any amendments to the grant application, to receive any grant funds that are awarded for the Project, and to execute any contracts, agreements, memoranda of agreement, and amendments thereto as may be required by program guidelines for the Project, and to exercise termination and modification provisions contained therein, all of which are subject to the County Attorney's Office's approval for form and legal sufficiency.

Section 4. This Board also authorizes the County Mayor or the County Mayor's designee, acting as fiscal agent for the Eleventh Judicial Circuit of Florida, to apply for and receive additional future funds that may become available for the Project, to execute any contracts, agreements, memoranda of agreement, or amendments that may be necessary for the receipt of additional available funds for the Project, and to exercise termination and modification provisions contained therein, subject to the County Attorney's Office's approval for form and legal sufficiency.
