Subject: Recommendation to Ratify Emergency Award: Stephen P. Clark West Side Risers

Resolution No. R-894-21

Recommendation

It is recommended that the Board of County Commissioners (Board) waive formal bid procedures pursuant to Section 5.03(D) of the Home Rule Charter and Section 2-8.1(b)(3) of the Miami-Dade County Code, by a two-thirds vote of the Board members present, and ratify an emergency contract award, *Contract No. E-10123, West Side Risers* (aka vertical domestic water and, sewer lines and vents), to Regosa Engineering Services, Inc. (Regosa) in the amount of \$608,337 for the Internal Services Department (ISD). These services are exempt from competitive bidding pursuant to Florida Statute 255.20(1)(c) because of repairs needed due to the unexpected damage that posed an immediate danger to the public health and safety of employees and visitors to the Stephen P. Clark Center (SPCC).

An emergency was declared under the delegated authority of the then Director of ISD for the sewer line that erupted in the third-floor restroom of the Stephen P. Clark Center (SPCC) on January 21, 2020. This eruption caused significant water damage to the second and third floor bathrooms, terrace, and the first-floor electrical room. Due to the severity of the damage, a complete assessment of the SPCC sewer lines and vent risers was conducted, where it was discovered that the sanitary sewer vent line had suffered cracks in multiple locations throughout SPCC, in addition to damages to several areas of the west side riser. These vertical domestic water and sewer lines, and vent allow for the proper flow of sewage and channel the sewer gases up to the roof and out of the building.

Subsequently, as a result of the discoveries made during the assessment of the SPCC west side risers, it was determined that all of the vertical domestic water and sewer lines and vents on the west side of the building needed to be immediately replaced as a result of the January eruption. To accomplish this, it was necessary for Regosa to design and obtain the proper permits and inspection for repairs to cure the deficiencies. Various revisions of the design, permitting requirements, and budget were also needed during the planning phases due to the complexity of the work. This process was delayed for several months due to unforeseen conditions related to wall restoration requirements, additional damages discovered and design and permitting requirements.

The critical deficiencies of the west side riser posed a health risk to employees and visitors due to possible flooding of the floors, elevators, and lobby. Closing restrooms in the SPCC due to these major leaks would prompt RER code compliance to shut down the building, which would affect operations and interrupt essential governmental services. Consequently, due to these critical circumstances, on December 23, 2020, the then Director of ISD determined that an emergency declaration was required in order to expedite these repairs related to the west end risers, to ensure the health, safety and welfare of the employees and visitors at the SPCC, and this item is being submitted for ratification by the Board to complete the necessary work for the SPCC west side risers. ISD will utilize the Miscellaneous Construction Contracts Program for future assessments and repairs. This will allow ISD to access these services more quickly without an emergency declaration.

Regosa was already familiar with work needed and was retained to perform the services as competition for these services was not practicable due to the urgency to effect the emergency repairs and address critical deficiencies. The importance of proceeding with repairs was paramount to effectively prevent future emergencies which could cause substantial damage to the building, including millions of dollars in water damage which could potentially promote the growth of mold and mildew thereby affecting the indoor air quality.

Scope

The SPCC building is located in Commission District 5 which is represented by Commissioner Eileen Higgins, however, the impact of this item is countywide in nature due to the nature and variety of services that the building houses which service the entire County.

Delegated Authority

There is no delegation of authority sought because this item is a ratification of a completed emergency purchase.

Fiscal Impact/Funding Source

The fiscal impact of this emergency purchase is \$608,337.

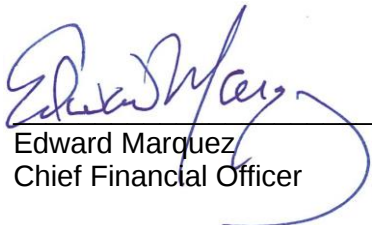
Due Diligence

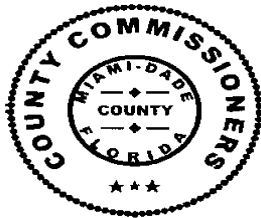
