RESOLUTION APPROVING THE CITY OF MIAMI SPRINGS
CODESIGNATION OF A PORTION OF PARK STREET
BETWEEN WESTWARD DRIVE AND HIBISCUS DRIVE AS
“MIAMI SPRINGS WOMAN’S CLUB WAY”

WHEREAS, on May 10, 2021, the City of Miami Springs Council passed Resolution No. 2021-3913 which codesignated a portion of Park Street between Westward Drive and Hibiscus Drive as “Miami Springs Woman’s Club Way”; and

WHEREAS, a copy of Resolution No. 2021-3913 is attached hereto and incorporated herein by reference; and

WHEREAS, the Miami Springs Woman’s Club was founded on May 22, 1939, and is a significant charitable, educational, and social presence in the community; and

WHEREAS, the Miami Springs Woman’s Club is a 501(c)(3) charitable and educational non-profit organization; and

WHEREAS, the Miami Springs Woman’s Club has demonstrated its commitment to the community by establishing nursing scholarships, maintaining a historical library, and feeding hungry children in the community; and

WHEREAS, that portion of Park Street between Westward Drive and Hibiscus Drive identified by the City of Miami Springs is a city road located in the City of Miami Springs; and

WHEREAS, this codesignation is located in County Commission District 6; and

WHEREAS, this Board would also like to honor the Miami Springs Woman’s Club by approving the City of Miami Springs’ codesignation of that portion of Park Street between Westward Drive and Hibiscus Drive as “Miami Springs Woman’s Club Way”,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

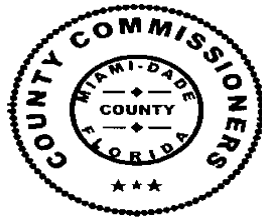
Section 1. Approves the City of Miami Springs’ codesignation of that portion of Park Street between Westward Drive and Hibiscus Drive as “Miami Springs Woman’s Club Way”.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Mayor and City Council of the City of Miami Springs, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, Miami-Dade Fire Rescue Department, and the City of Miami Springs Police Department.

RESOLUTION NO. 2021 - 3913

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MIAMI SPRINGS, FLORIDA, CO-DESIGNATING THE PORTION OF PARK STREET BETWEEN WESTWARD DRIVE AND HIBISCUS DRIVE AS “MIAMI SPRINGS WOMAN’S CLUB WAY”; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Miami Springs (the “City”) Council hereby seeks to recognize and honor the Miami Springs Woman’s Club; and

WHEREAS, the Miami Springs Woman’s Club was founded on May 22, 1939, and has been a significant charitable, educational and social presence in the community ever since; and

WHEREAS, the Miami Springs Woman’s Club is a 501(c)(3) charitable and educational non-profit organization; and

WHEREAS, one of the Miami Springs Woman’s Club’s most significant projects included the establishment of the first public library within the City; and

WHEREAS, the Miami Springs Woman’s Club is dedicated to community improvement and towards that end maintains a medical loan closet, which provides medical equipment to the community at no charge, awards a Lena Curtiss Wheeler Nursing Scholarship to a deserving nursing student each year, feed hungry children, and maintain a historical library; and

WHEREAS, the City Council has determined that it is proper and appropriate to recognize the Miami Springs Woman’s Club by co-designating the portion of Park Street between Westward Drive and Hibiscus Drive as “Miami Springs Woman’s Club Way”; and

WHEREAS, the City Council finds that this Resolution is in the best interest and welfare of the residents of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MIAMI SPRINGS, FLORIDA, AS FOLLOWS:

Section 1. Recitals. That the above recitals are confirmed, adopted, and incorporated herein and made a part hereof by reference.

Section 2. Co-Designation. The City Council hereby approves the co-designation of the portion of Park Street between Westward Drive and Hibiscus Drive as “Miami Springs Woman’s Club Way” as shown on Exhibit “A” attached hereto.

Section 3. Authorization. The City Council authorizes the City Manager to take all actions necessary to implement this Resolution. The City Manager is authorized to place the appropriate signage or markers along the designated area.

Section 4. Effective Date. That this Resolution shall be effective immediately upon adoption.
