Subject: Resolution Approving the Plat of Marcelo Subdivision Filed by Alejandro G. Pino
and Katrina M. Silva

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Marcelo Subdivision is bounded on the north approximately 390 feet south of SW 68 Street, on the east by SW 70 Avenue, on the south by SW 70 Street, and on the west approximately 90 feet east of SW 71 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board’s meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 7, which is represented by Commissioner Raquel Regalado.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this plat as all improvements are in place.

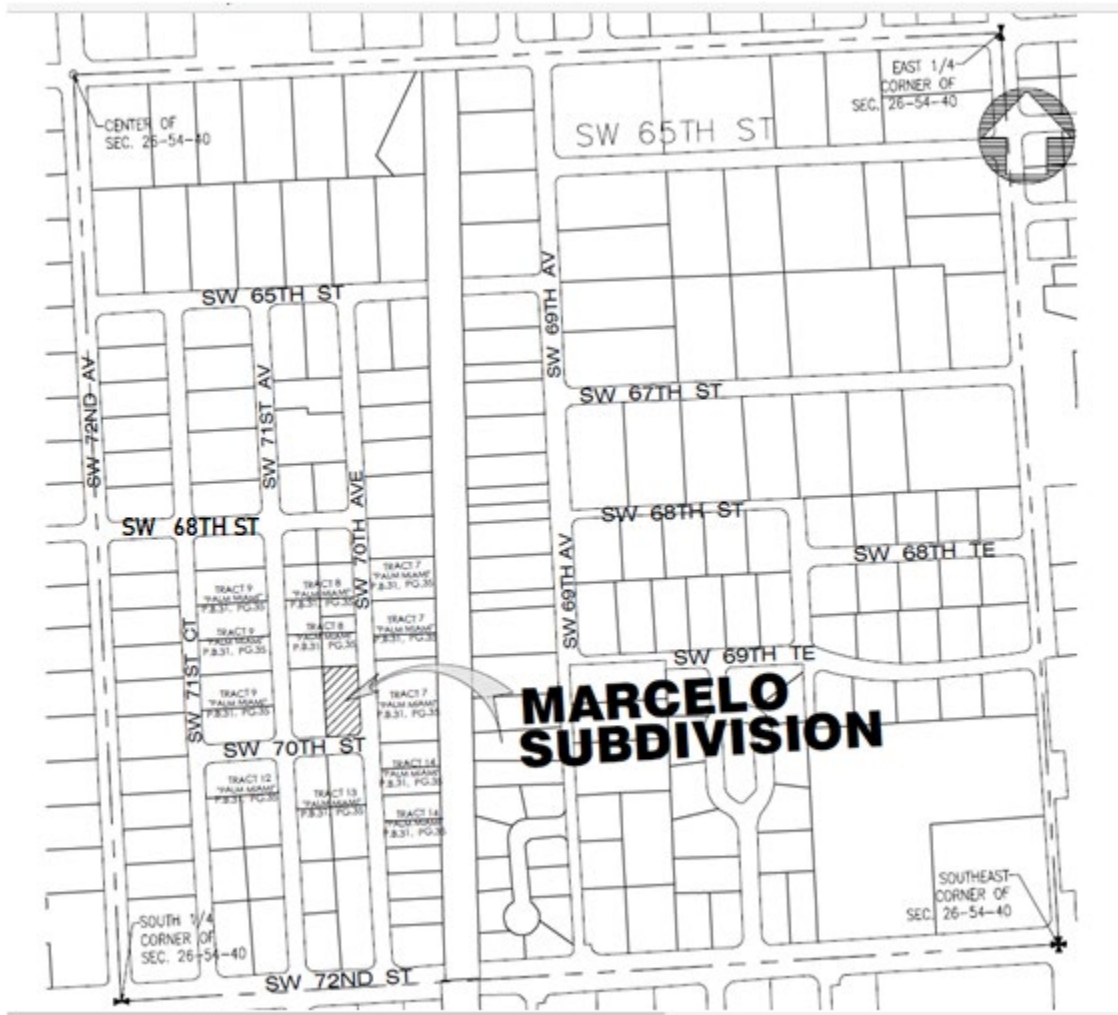

RESOLUTION NO. R-791-21

RESOLUTION APPROVING THE PLAT OF MARCELO SUBDIVISION FILED BY ALEJANDRO G. PINO AND KATRINA M. SILVA, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 26, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH APPROXIMATELY 390 FEET SOUTH OF SW 68 STREET, ON THE EAST BY SW 70 AVENUE, ON THE SOUTH BY SW 70 STREET, AND ON THE WEST APPROXIMATELY 90 FEET EAST OF SW 71 AVENUE)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Alejandro G. Pino, a single man and Katrina M. Silva, a single woman, as Joint Tenants with Right of Survivorship, have this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as “Marcelo Subdivision,” the same being a replat of a portion of Tract 8 of “Amended Plat of a Portion of Palm-Miami,” according to the plat thereof, as recorded in Plat Book 31, at Page 35 of the Public Records of Miami-Dade County, Florida, lying and being in the Southeast 1/4 of Section 26, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any

zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.

The foregoing resolution was offered by Commissioner **Joe A. Martinez**, who moved its adoption. The motion was seconded by Commissioner **Sally A. Heyman** and upon being put to a vote, the vote was as follows:
