Subject: Request for Additional Expenditure Authority to Pool No. 8073-1/20-1, Veterinary Supplies and Pharmaceuticals

Recommendation

It is recommended that the Board of County Commissioners (Board) authorize additional expenditure authority to *Pool No. 8073-1/20-1, Veterinary Supplies and Pharmaceuticals* for the Animal Services Department (ASD). The Department is requesting \$2,000,000 in additional expenditure to continue purchasing veterinary and pharmaceutical supplies to provide low cost and free vaccination and sterilization services to the public as well as improved standards of veterinary care for more than 30,000 shelter animals, and enhanced vaccination protocols to prevent the spread of diseases among animals.

There are 11 active vendors in the pool, three of which have local addresses and two are certified Small Business Enterprise firms. Additional vendors may be added throughout the term of the pool.

The pool was established under delegated authority on January 20, 2012, for a five-year term with one, five-year option to renew term. On September 16, 2014, through Resolution No. R-806-14, the Board ratified the establishment of the pool. Subsequently, on October 3, 2019, through Resolution No. R-1028-19, the Board authorized additional expenditure authority in the amount of \$2,655,000, increasing the total allocation to \$11,225,000.

Additional expenditure authority is required to:

- Replenish funds expended based on an unanticipated increase in request for mobile services and medical treatment of animals at the Pet Adoption and Protection Center and Homestead Clinic. The ASD Homestead Clinic increased operations from 3 days per week to 5 days per week resulting in an increased need for pharmaceutical supplies. ASD and Friends Of Miami Animals have recently launched a mobile wellness clinic which operates 5 days per week and provides treatment to community pets.
- Increase resources to meet the improved No Kill Program and expansion of life saving efforts under Resolution No. R-1255-20, the Save Charlie Act. The implementation of the Save Charlie Act may lead to an increased need for pharmaceutical resources.
- Purchase testing kits for the detection of diseases in animals such as heartworm, lyme, feline immunodeficiency, feline leukemia and canine parvovirus. These kits were previously purchased under *Contract No. FB-00264, Veterinary Supplies and Services* but was consolidated under the pool to mitigate supply challenges and to address pricing fluctuations. The requested amount will cover the department's operational needs through the remainder of the contract term.

Scope

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The pool term expires on January 31, 2022 and has a current cumulative allocation of \$11,225,000. If this request is approved, the pool will have a modified cumulative allocation of \$13,225,000. The requested increase in expenditure authority is based on the anticipated operational needs of the Department for the remainder of the pool term.

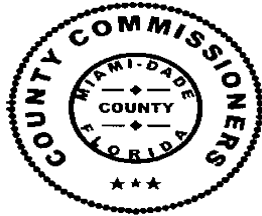
WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,
