Filed by B & R Investments Alliance Corp.

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for B & R Investments Alliance Corp. is bounded on the north by NW 96 street, on the east approximately 80 feet west of NW 23 Avenue, on the south approximately 100 feet north of NW 95 Terrace, and on the west approximately 460 feet east of NW 24 Avenue.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board’s meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Legal description of the boundaries of the land are on file with the Department of Regulatory and Economic Resources.

Scope

This waiver of plat is located in Commission District 2, which is represented by Commissioner Jean Monestime.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this waiver of plat as all improvements are in place.

Track Record/Monitor

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

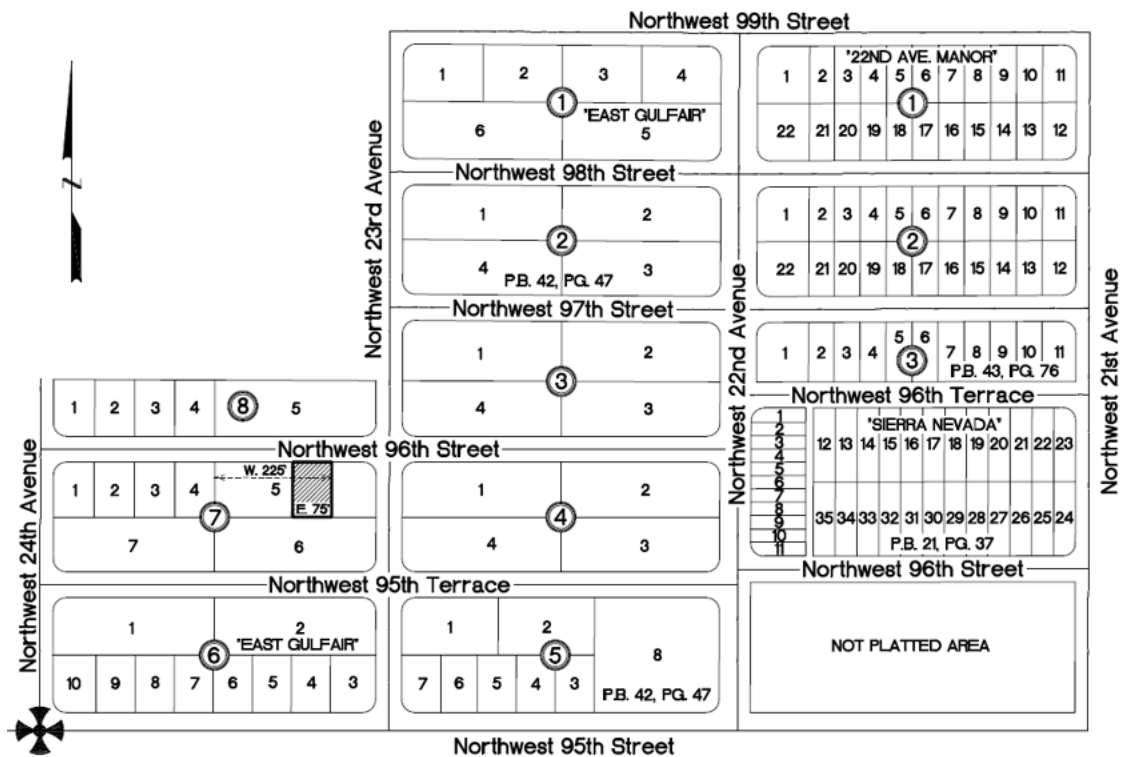

RESOLUTION APPROVING THE WAIVER OF PLAT OF B & R INVESTMENTS ALLIANCE CORP., D-24574, FILED BY B & R INVESTMENTS ALLIANCE CORP, LOCATED IN THE NORTHWEST 1/4 OF SECTION 3, TOWNSHIP 53 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH BY NW 96 STREET, ON THE EAST APPROXIMATELY 80 FEET WEST OF NW 23 AVENUE, ON THE SOUTH APPROXIMATELY 100 FEET NORTH OF NW 95 TERRACE, AND ON THE WEST APPROXIMATELY 460 FEET EAST OF NW 24 AVENUE)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, B & R Investments Alliance Corp., a Florida corporation, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Lot 5, Block 7, of “East Gulfair”, according to the plat thereof, as recorded in Plat Book 42, at Page 47, of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 3, Township 53 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

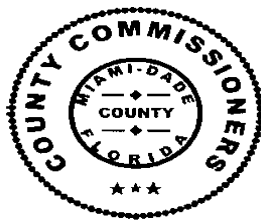

is approved shall be enforced whether or not the various parcels on this waiver of plat conforms to those requirements.
