RESOLUTION DIRECTING THE COUNTY MAYOR OR
COUNTY MAYOR'S DESIGNEE TO PREPARE A
REPORT REGARDING THE FEASIBILITY AND
ADVISABILITY OF EXPANDING LITTLE FREE
LIBRARIES THROUGHOUT MIAMI-DADE COUNTY

WHEREAS, the Little Free Library is a global literacy movement with 100,000 registered mini-libraries in all 50 states and 108 countries around the globe. To date, more than 120 million books have been shared through this program; and

WHEREAS, a Little Free Library is a “take a book, return a book” free book exchange. They come in many shapes and sizes, but the most common version is a small wooden box of books. Anyone may take a book or bring a book to share; and

WHEREAS, residents can register the Little Free Libraries installed on their properties with the Little Free Libraries organization at their website www.littlefreelibrary.org so that members of the community can locate Little Free Libraries throughout the County; and

WHEREAS, municipalities such as Coral Gables have begun programs for the sponsorship of Little Free Libraries at parks; and

WHEREAS, Little Free Libraries may be able to be installed on County property such as County parks; and

WHEREAS, a sponsorship program may be possible whereby individuals or businesses could defray the cost of the Little Free Library and assist in maintenance; and

WHEREAS, there may be individuals in Miami-Dade County who would like to install Little Free Libraries on their property but are uncertain as to any regulations surrounding their installation; and

WHEREAS, Little Free Libraries can be installed on private property in a way that does not require County permitting and encourages public access to Little Free Libraries; and

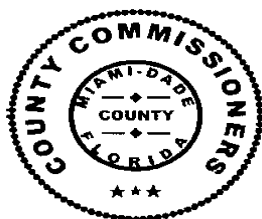
WHEREAS, this Board supports an increase in Little Free Libraries throughout the County,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby directs the County Mayor or County Mayor’s designee to, within 80 days of the effective date of the is resolution, prepare a written report that explores the feasibility and advisability of expanding Little Free Libraries throughout Miami-Dade County. Such report shall include whether a sponsorship program could be established for Little Free Libraries on County property, what impediments and regulations exist regarding individual property owners to installing Little Free Libraries on their own property, and whether there are any impediments to installing Little Free Libraries on County property, such as County parks. The completed report to this Board shall be placed on an agenda of this Board in accordance with Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Commissioner Raquel A. Regalado. It was offered by Commissioner **Raquel A. Regalado** , who moved its adoption. The motion was seconded by Commissioner **Joe A. Martinez** and upon being put to a vote, the vote was as follows:
