RESOLUTION NO. _____ R-882-21

RESOLUTION CODESIGNATING THAT PORTION OF
NORTHWEST 25TH AVENUE AT ITS INTERSECTION WITH
NORTHWEST 102ND STREET AS “JADA PAGE
BOULEVARD”

WHEREAS, her name was Jada Page, and in the early weeks of August 2016, she was an energetic and excited 4th grader at Sea Castle Elementary School with plans to make her mark on what promised to be an unforgettable school year; and

WHEREAS, at eight years old, Jada loved to move to the sounds and rhythms of her favorite songs, always knowing the latest dance moves and teaching them to her family and friends; and

WHEREAS, Jada was also very creative and often came up with new ideas to design apparel such as colorful backpacks; and

WHEREAS, Jada had a zest and zeal for life; and

WHEREAS, each day that she lived, Jada Page lit up every room she entered, injecting the atmosphere with her infectious smile and undeniable energy, beaming with pride in her roles as a daughter, sister, family member, and friend; and

WHEREAS, hers was a life of purpose and promise that was senselessly cut short when she was gunned down one fateful afternoon on her own front porch as she prepared to accompany her father to the movies; and

WHEREAS, on August 30, 2016, the sound of her laughter was silenced as she fought valiantly to survive her fatal injuries during the days that followed; and

WHEREAS, according to her mother Rosalind Brown, Jada Page “wanted to live”; and

WHEREAS, Jada was not alone in her desire to live—in fact, many throughout Miami-Dade County joined together in the weeks that followed, rallying, protesting, and earnestly trying to bring justice to her young life and legacy and condemn the reality that her days had violently been cut short; and

WHEREAS, the mark of justice remains the steadfast goal of both her family and the Miami-Dade County community at-large; and

WHEREAS, it is the memory of Jada’s short yet impactful life that continues to guide the light post of hope and drive the mission of change; and

WHEREAS, today, the Jada Page Foundation (the “Foundation”), stands as a physical manifestation of her family’s plight to keep her memory alive; and

WHEREAS, established in 2017 and led by her mother Ms. Brown, the Foundation focuses on bringing much-needed awareness to senseless gun violence through outreach, advocacy, and educational training; and

WHEREAS, youth in Miami-Dade County have also benefitted from the Jada Club, a summer program that affords participants an opportunity to explore a variety of extracurricular activities and areas ranging from music to entrepreneurship; and

WHEREAS, in the spirit of honoring and shining an eternal light on the beautiful life of Jada Page, it is fitting that this Board permanently etch her name in the annals of Miami-Dade County history; and

WHEREAS, the portion of Northwest 25th Avenue at its intersection with Northwest 102nd Street is a County maintained road located in unincorporated Miami-Dade County; and

WHEREAS, this proposed codesignation is located in County Commission District 2; and

WHEREAS, to honor the memory of Jada Page whose light of life was extinguished well before its time and whose legacy stands as a continued charge for change, this Board wishes to codesignate that portion of Northwest 25th Avenue at its intersection with Northwest 102nd Street as “Jada Page Boulevard”,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

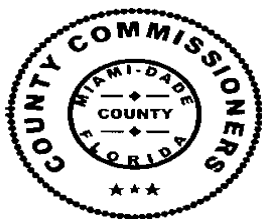
Section 1. Having considered this matter at a public hearing, codesignates that portion of Northwest 25th Avenue at its intersection with Northwest 102nd Street as “Jada Page Boulevard”.

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade County Police Department and the Miami-Dade County Fire-Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Jean Monestime. It was offered by Commissioner **Jean Monestime** , who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
