RESOLUTION NO. R-957-21

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO ENTER INTO NEGOTIATIONS WITH PAYPAL, INC. AND OTHER ONLINE PAYMENT SYSTEMS, EXAMINE THE FEASIBILITY OF ALLOWING INDIVIDUALS TO PAY FOR COUNTY FEES AND SERVICES USING PAYPAL AND OTHER ONLINE PAYMENT SYSTEMS, AND PROVIDE A REPORT

WHEREAS, mobile and electronic payments are increasingly becoming the preferred payment option for consumers; and

WHEREAS, according to a 2019 Federal Reserve Payments Study, there were a total of 174.2 billion noncash payments in 2018 with the value of these payments totaling \$97.04 trillion; and

WHEREAS, in addition to more traditional noncash payment options like credit and debit cards, consumers are also using online payment systems, such as PayPal, with increasing frequency; and

WHEREAS, PayPal, for example, completed over 20 billion transactions in 2020 with the value of these payments totaling \$936 billion; and

WHEREAS, various governments at the federal, state, and local level ranging from over 200 federal agencies to the City of Miami Lakes have begun to accept PayPal for the payment of fees and services; and

WHEREAS, individuals paying for County fees or services would benefit from having multiple payment options made available to them,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board finds that it would be in the best interests of the County to expand the available options to pay for County fees and services to include PayPal >>and other online payment systems<<.¹

Section 2. The County Mayor or County Mayor's designee is hereby directed to enter into negotiations with PayPal, Inc. >>and other online payment systems<< and examine the feasibility of allowing individuals to pay for County fees and services using ~~[[PayPal's digital and online payment system]]~~ >>PayPal and other online payment systems<<, excluding the ability to pay using cryptocurrency. Following negotiations with PayPal >>and other online payment systems<<, the County Mayor shall provide a feasibility report to this Board that shall include, at a minimum, the following: (1) the benefits to the County for including PayPal >>and other online payment systems<< as a payment option for County fees and services; (2) whether the County's existing contracts for payment processing allow for the potential to integrate with PayPal's services >>and other online payment systems<< and if doing so would be the most cost effective and expeditious manner to include PayPal >>and other online payment systems<< as a payment option; and (3) if additional contracting is required, whether inclusion of PayPal >>and other online payment systems<< as a payment option can be accomplished with formal competitive bidding and, if not, whether it would be in the County's best interest to waive such competitive procedures including any necessary justifications required under applicable law. Such report shall be provided to the Board within ~~[[80]]~~ >>180<< days after the effective date of this resolution and be placed

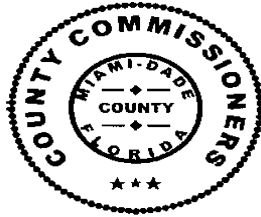
on an agenda of this Board pursuant to Ordinance No. 14-65. And, to the extent further action is required to include PayPal >>and other online payment systems<< as a payment option for County fees and services, the County Mayor or County Mayor's designee shall also present necessary amendments to existing contracts and recommendations for any new contract awards to this Board for approval as soon as practicable.

Section 2. If the County Mayor or County Mayor's designee has not concluded negotiations with PayPal >>and other online payment systems<< within ~~[[80]]~~ >>180<< days after the effective date of this resolution, then the County Mayor or County Mayor's designee shall provide the Board with a status report describing efforts thus far undertaken to accomplish the directives in Section 1. The completed report shall be placed on an agenda of this Board pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Commissioner Raquel A. Regalado. It was offered by Commissioner **Raquel A. Regalado**, who moved its adoption. The motion was seconded by Commissioner **Joe A. Martinez** and upon being put to a vote, the vote was as follows:
