Subject: Resolution Approving the Waiver of Plat of Silver One Investments, LLC Filed
by Silver One Investments, LLC

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for Silver One Investments, LLC is bounded on the north approximately 130 feet south of NW 111 Street, on the east by NW 19 Avenue, on the south approximately 760 feet north of NW 107 Street, and on the west approximately 810 feet east of NW 21 Court.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board’s meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Legal description of the boundaries of the land are on file with the Department of Regulatory and Economic Resources.

Scope

This waiver of plat is located in Commission District 2, which is represented by Commissioner Jean Monestime.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

If this waiver of plat is approved, the fiscal impact to the County would be approximately \$150.00 annually for roadway construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works’ annual General Fund allocation.

Track Record/Monitor

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

Background

Silver One Investments, LLC (D-24385)

- Located in Section 34, Township 52 South, Range 41 East.
- Zoning: RU-1.
- Proposed usage: Two single family residences.
- Number of parcels: Two.
- This waiver of plat meets concurrency.
- Available public water lines abut the proposed subdivision. Public sanitary sewers are not within feasible distance to the subdivision. Each Parcel will be served by a septic tank and drainfield.

Developer’s Obligation

Mobilization, clearing, maintenance of traffic, paving, sidewalk, drainage, and monumentation which are bonded under bond number 8191 in the amount of \$22,748.00.

RESOLUTION APPROVING THE WAIVER OF PLAT OF SILVER ONE INVESTMENTS, LLC, D-24385, FILED BY SILVER ONE INVESTMENTS, LLC, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 34, TOWNSHIP 52 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH APPROXIMATELY 130 FEET SOUTH OF NW 111 STREET, ON THE EAST BY NW 19 AVENUE, ON THE SOUTH APPROXIMATELY 760 FEET NORTH OF NW 107 STREET, AND ON THE WEST APPROXIMATELY 810 FEET EAST OF NW 21 COURT)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Silver One Investments, LLC, a Florida limited liability company, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Lot 1, Block 1, of “Little River Farms,” according to the plat thereof, as recorded in Plat Book 44, at Page 39, of the Public Records of Miami-Dade County, Florida, lying and being in the Southeast 1/4 of Section 34, Township 52 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

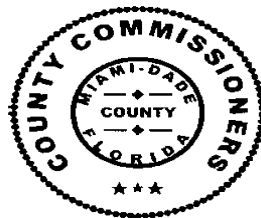

of any zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this waiver of plat conforms to those requirements.
