Subject: Resolution Approving the Plat of 7-Eleven Miller Drive Filed by 30025 Miami FL,

LLC.

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for 7-Eleven Miller Drive is bounded on the north by SW 56 Street, on the east by SW 67 Avenue, on the south approximately 360 feet north of SW 57 Terrace, and on the west approximately 340 feet east of SW 68 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 7, which is represented by Commissioner Raquel A. Regalado.

There are no delegation requirements with this item.

- Available public water and sewer lines abut the proposed subdivision. The parcel is required to connect to public water and public sanitary sewers.



RESOLUTION APPROVING THE PLAT OF 7-ELEVEN MILLER DRIVE FILED BY 30025 MIAMI FL, LLC, LOCATED IN THE NORTHEAST 1/4 OF SECTION 26, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 56 STREET, ON THE EAST BY SW 67 AVENUE, ON THE SOUTH APPROXIMATELY 360 FEET NORTH OF SW 57 TERRACE, AND ON THE WEST APPROXIMATELY 340 FEET EAST OF SW 68 AVENUE)
