Resolution Approving Implementing Order No. 2-15 Regarding Form of Parking Citations

### Recommendation

It is recommended that the Board of County Commissioners (Board) approve the attached new Implementing Order (IO) 2-15: Form of Parking Citations. The IO, which is required by recent amendments to Chapter 30 of the Miami-Dade County Code (Miami-Dade Parking Ordinance), creates countywide standards for the form of both paper and electronic parking citations consistent with current practice and the requirements of the Clerk of Courts.

### Scope

The scope of this IO is countywide.

### Fiscal Impact/Funding Source

This IO is not expected to have a fiscal impact to the County.

### Track Record/Monitor

The Miami-Dade Police Department and County departments that enforce parking regulations at their facilities, such as Miami-Dade Aviation, Seaport, Transportation and Public Works and Parks, Recreation and Open Spaces Departments will continue to be responsible for complying with the required form of parking citations. Municipalities are authorized to enforce the provisions of the Miami-Dade Parking Ordinance within their municipal boundaries and are required to comply with these requirements as well.

The Clerk of Courts Parking Violations Bureau will continue to be responsible for overseeing and communicating all requirements regarding the form of parking citations, consistent with this IO.

### **Delegated Authority**

This IO does not provide any additional delegated authority beyond that which is already in the Miami-Dade Parking Ordinance and currently exists for administration of parking. The Miami-Dade Police Department and County departments that enforce parking regulations at their facilities will continue to work with the Clerk of Courts Parking Violations Bureau on the implementation of the updated forms of the parking citations in accordance with the Miami-Dade Parking Ordinance.

### Background

On July 20, 2021, the Board approved amendments to Chapter 30 of the County Code related to parking enforcement (the Miami-Dade Parking Ordinance) via Ordinance No. 21-75. The Miami-Dade Parking Ordinance provides that the requirements for the form of citations be used for violations of the Miami-Dade Parking Ordinance and established by Implementing Order of the Board. Ordinance No. 21-75 included an implementation delay of six months, thereby making the amendments to Chapter 30 effective on January 20, 2022.

The attached IO, if approved, fulfills the requirements of the Miami-Dade Parking Ordinance. The IO establishes countywide standards for the form of both paper and electronic parking citations which are consistent with current practice and conform to the requirements of the Clerk of Courts.

Required information on all parking citations will include the citation number; the nature of the violation; the jurisdiction, date and time of the violation; the name, title and signature of the enforcement officer; and identifying information for the vehicle. Additionally, the citation must advise violators of the deadline to make payment or to request a hearing; inform violators how payment can be made on the parking citation; and inform violators of the means by which a hearing may be requested.

# MIAMI-DADE COUNTY IMPLEMENTING ORDER

### FORM OF PARKING CITATIONS

### **AUTHORITY:**

The Miami-Dade County Home Rule Charter, including, among others, Sections 1.01, 2.02(A), 5.01 and 5.03, and Chapter 30 of the Code of Miami-Dade County.

### POLICY:

It is the policy of Miami-Dade County that all parking citations issued by all law enforcement officers and parking enforcement specialists of the County and of all municipalities enforcing the Miami-Dade County Parking Code comply with the requirements of the Clerk of Courts with respect to form and transmission and with the standards set forth herein.

### FORM OF PARKING CITATIONS:

- (1) All citations issued for violations of the Miami-Dade Parking Code issued by County or municipal law enforcement officers or parking enforcement specialists will include a citation number that has been assigned and issued by the Clerk of Courts.
- (2) All paper citations issued for violations of the Miami-Dade Parking Code issued by County or municipal law enforcement officers or parking enforcement specialists must conform to the universal size and format required by the Clerk of Courts.
- (3) Electronic citations issued for violations of the Miami-Dade Parking Code issued by County or municipal law enforcement officers or parking enforcement specialists must conform to the Clerk of Courts' technical specifications. Each enforcement agency shall consult and coordinate with the Clerk of Courts to ensure technical conformity.

### (4) All parking citations must:

- a) Set forth the specific parking regulation or regulations, including by reference and identification to the section of the Miami-Dade County Parking Code, that is being violated.
- b) Set forth the amount of the fine associated with the violation or violations of the Miami-Dade County Parking Code, including the fine amount if payment is not received within 30 days.
- c) Set forth the jurisdiction, date and time of the violation. For citations that are to

be mailed to the registered owner of the vehicle, an additional date, titled "Parking Citation Date" shall be included on the parking citation and such Parking Citation Date shall be a date that is 5 days from the date of the violation to account for the mailing time.

d) Include the name, title and signature of the enforcement officer.

e) Include identifying information for the vehicle including license plate number and state (or VIN number for vehicles with temporary, out of state or no license plate), tag expiration date, decal number and vehicle make, model and color.

f) Advise violators that, for violations of the Miami-Dade Parking Code, the deadline to make payment or to request a hearing before a hearing officer is: (1) for citations issued directly to drivers or attached to vehicles, 30 days from the date of the violation noted on the parking citation; and (2) for citations mailed to the registered owner of the vehicle, 30 days from the Parking Citation Date noted on the parking citation.

g) Inform violators of the means and locations by which payment can be made, which may include, but is not limited to, payment by cash, check, credit card or other electronic means, and at in-person locations, by mail or by electronic means. Citations for violations of the Miami-Dade County Parking Code shall include the requirement that all payments for violations of the Miami-Dade County Parking Code be made to the Clerk of Court.

h) Inform violators of the means by which a hearing before a hearing officer may be requested. Citations for violations of the Miami-Dade Parking Code shall include the requirement that all requests for a hearing before a hearing officer must be made directly to the Clerk of Courts.
