RESOLUTION APPROVING THE CITY OF MIAMI'S
CODESIGNATION OF THAT PORTION OF SOUTHWEST
36TH COURT FROM SOUTHWEST 8TH STREET TO
SOUTHWEST 11TH STREET AS "CONCHA VALDÉS
MIRANDA WAY"

WHEREAS, Concha Valdés Miranda ("Valdés Miranda") was born on July 16, 1928, in
Havana, Cuba; and

WHEREAS, Valdés Miranda became a songwriter and performer of Cuban music, and is
considered to be one of the most important composers of contemporary Bolero; and

WHEREAS, Valdés Miranda's most renowned global success was *El Que Mas Te Ha
Querido (The One Who Loved You the Most)*, which was performed by legendary Spanish singer
Dyango, was nominated for a Grammy, and reached number one on the Billboard Latin Radio
charts; and

WHEREAS, Valdés Miranda is also the author of numerous songs performed by Olga
Guillot, Tona la Negra, Celia Cruz, Lucia Mendez, Blanca Rosa Gil, Imelda Miller, Sandro, Tito
Rodriguez, Felipe Pirela, Los Panchos, Gilberto Santa Rosa, Santos Colon, Alberto Vazquez,
Maria Marta Serra Lima, Sophy, Dyango, Floria Marquez, Elena Burke, Ismael Miranda, Tito
Nieves, Tito Puente, John Secada, Sergio Vargas, Jose Alberto "El Canario", Johnny Ventura,
Cheo Feliciano, Moncho y Dyango, and others; and

WHEREAS, many of Valdés Miranda's compositions have been used in Spanish and
Mexican movies; and

WHEREAS, in the early 1960s, along with a close-knit group of the most talented songwriters and poets who fled during the Cuban Revolution and arrived in the City of Miami, including Jose Carbo Menendez and Elena Casais, Valdés Miranda founded the organization La Sociedad de Compositores y Autores Cubanos en el Exilio (The Society of Exiled Cuban Songwriters and Authors); and

WHEREAS, Valdés Miranda was the first woman inducted into the Latin Songwriters Hall of Fame at the inaugural La Musa Awards in 2013; and

WHEREAS, Valdés Miranda passed away on August 19, 2017; and

WHEREAS, in honor of Valdés Miranda, the City Commission of the City of Miami, on November 18, 2021, adopted Resolution No. R-21-0484, which codesignated that portion of Southwest 36th Court from Southwest 8th Street to Southwest 11th Street as “Concha Valdés Miranda Way”; and

WHEREAS, a copy of Resolution No. R-21-0484 is attached hereto and incorporated by reference; and

WHEREAS, the City of Miami would like the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

WHEREAS, this Board would also like to honor Valdés Miranda by approving the City of Miami’s codesignation of that portion of Southwest 36th Court from Southwest 8th Street to Southwest 11th Street as “Concha Valdés Miranda Way”; and

WHEREAS, Southwest 36th Court from Southwest 8th Street to Southwest 11th Street is a city-maintained road located in the City of Miami; and

WHEREAS, this codesignation is located in County Commission District 7,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Miami’s codesignation of that portion of Southwest 36th Court from Southwest 8th Street to Southwest 11th Street as “Concha Valdés Miranda Way.”

Section 2. Directs the Clerk of the Board to transmit certified copies of this Resolution to the Mayor and City Commission of the City of Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the City of Miami Police Department, and the City of Miami Department of Fire-Rescue.

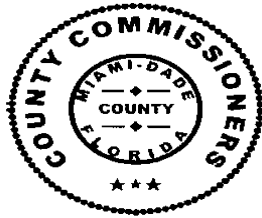

A RESOLUTION OF THE MIAMI CITY COMMISSION CO-DESIGNATING SOUTHWEST 36TH COURT FROM SOUTHWEST 8TH STREET TO SOUTHWEST 11TH STREET, MIAMI, FLORIDA AS "CONCHA VALDÉS MIRANDA WAY" PURSUANT TO SECTION 54-137 OF THE CODE OF THE CITY OF MIAMI, FLORIDA, AS AMENDED; FURTHER DIRECTING THE CITY CLERK TO TRANSMIT A COPY OF THIS RESOLUTION TO THE HEREIN DESIGNATED OFFICIALS.

WHEREAS, the City would like to honor Valdés Miranda by co-designating Southwest 36th Court from Southwest 8th Street to Southwest 11th Street, Miami, Florida as "Concha Valdés Miranda Way";

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

Section 1. The recitals and findings contained in the Preamble to this Resolution are adopted by reference and incorporated as if fully set forth in this Section.

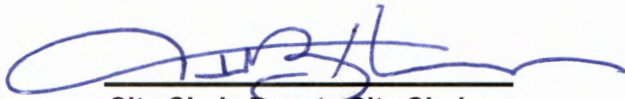
Section 2. The City Commission co-designates that portion within the City's limits of Southwest 36th Court from Southwest 8th Street to Southwest 11th Street, Miami, Florida as "Concha Valdés Miranda Way".

Section 3. The City Clerk is directed to transmit a certified copy of this Resolution to the Departments of Police, Fire-Rescue, and Solid Waste; the Miami-Dade County Department of Transportation and Public Works; the Miami-Dade County Commissioner of District 7; the United States Postal Service; and, if a State of Florida road, to the Florida Department of Transportation, District Six, for sign installation within the newly designated roadway.

Section 4. This Resolution shall become effective immediately upon its adoption.
