Our Lady of the Lakes Catholic School (Community-wide Spring Carnival)	\$	500.00,

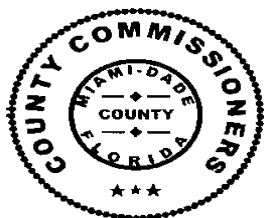
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
