(Homestead Rodeo Event) \$ 3,500.00

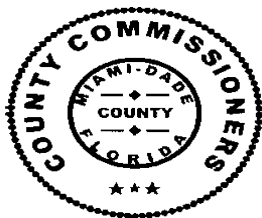
Dr. Martin Luther King Jr. Parade & Festivities Committee, Inc.
