RESOLUTION RECOGNIZING THE MONTH OF NOVEMBER 2022 AS MIAMI-DADE FARMER'S MONTH IN MIAMI-DADE COUNTY; RECOGNIZING THE MONTH OF NOVEMBER FOR EACH YEAR THEREAFTER AS MIAMI-DADE FARMER'S MONTH IN MIAMI-DADE COUNTY; DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO ENGAGE THE GREATER MIAMI CONVENTION AND VISITORS BUREAU TO DEVELOP PROGRAMMATIC EVENTS IN ADDITION TO ADVERTISEMENT AND A PUBLIC RELATIONS CAMPAIGN TO PROMOTE MIAMI-DADE FARMER'S MONTH AS WELL AS STIMULATE THE LOCAL AGRICULTURAL ECONOMY, AND TO PROVIDE A REPORT

WHEREAS, the agricultural industry is of great importance to Miami-Dade County (the

"County"), providing numerous jobs and having a significant economic impact; and

WHEREAS, the County has had a robust agricultural economy for over a century,

providing fresh vegetables, tropical fruits, and horticultural products to consumers across the

United States; and

WHEREAS, the County's agricultural industry is responsible for a significant amount of

the State of Florida's total production of tropical fruits and vegetables; and

WHEREAS, according to the 2017 Census of Agriculture, the County has over 78,000

acres of farmland and more than 2,750 farms, 95 percent of which are family farms; and

WHEREAS, the County is home to thousands of farmers; and

WHEREAS, farmers are essential workers that help feed the residents of this County and

individuals across the United States; and

WHEREAS, farming can be a difficult vocation and agriculture is a competitive industry;

and

WHEREAS, many farmers have worked throughout the coronavirus disease 2019 pandemic to help feed the residents of this County and individuals across the United States; and

WHEREAS, the Greater Miami Convention and Visitors Bureau ("GMCVB") has experience coordinating programs such as Miami Spice Months or Miami Spa Months; and

WHEREAS, Miami-Dade Farmer's Month is an opportunity for government, industry, and residents of the County to recognize the contributions that farmers make to our community,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Recognizes the month of November 2022 as Miami-Dade Farmer's Month in Miami-Dade County and further recognizes the month of November each year thereafter as Miami-Dade Farmer's Month in Miami-Dade County.

<u>Section 2.</u> Directs the County Mayor or County Mayor's Designee to engage the Greater Miami Convention and Visitors Bureau to develop programmatic events—including bundled discounts or passes to local businesses and agricultural attractions—in addition to advertisement and a public relations campaign to promote Miami-Dade Farmer's Month as well as stimulate the local agricultural economy. The County Mayor or Mayor's Designee shall provide a report to the Board within 60 days of the effective date of this resolution regarding the status and progress of the County's efforts to partner with the GMCVB to create events and advertisement for Miami-Dade Farmer's Month.

The Prime Sponsor of the foregoing resolution is Commissioner Danielle Cohen Higgins. It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The motion was seconded by Commissioner **Oliver G. Gilbert, III** and upon being put to a vote, the vote was as follows:
