RESOLUTION DIRECTING THE COUNTY MAYOR TO PROVIDE A REPORT REGARDING THE IMPLEMENTATION OF ORDINANCE NO. 18-9, REGARDING THE PROHIBITION ON CERTAIN OFFENDERS' ADOPTION OF ANIMALS FROM THE COUNTY

WHEREAS, in furtherance of this Board's longstanding commitment to combatting animal cruelty, this Board adopted Ordinance No. 18-9 (the "Ordinance"), codified as part of section 5-5 of the Code of Miami-Dade County, Florida; and

WHEREAS, the Ordinance generally prohibits individuals from adopting or otherwise acquiring animals impounded by the County's Animal Services Department (the "Department") if the individual is an "offender," meaning a person who has committed any of a number of enumerated animal-related offenses, such as animal cruelty; and

WHEREAS, the Ordinance also provides that any animal rescue organization to which the Department wishes to transfer animals shall enter into a written agreement with the County that, among other things, includes a promise from the organization that it will prohibit offenders from acquiring animals from the organization; and

WHEREAS, the County Mayor's fiscal impact statement submitted during the adoption process for the Ordinance identified two potential methodologies to implement the screening requirements of the Ordinance: (1) the development of a searchable database by the County's Information Technology Department; and (2) the establishment of a practice by the Animal Services Department to conduct background searches on potential adopters on an as-needed basis through the Florida Department of Law Enforcement's Instant Criminal History Check; and

WHEREAS, in section 5 of the Ordinance, this Board also directed the County Mayor or County Mayor's designee to coordinate with the Clerk of Courts or the Miami-Dade County State Attorney's Office regarding information on individuals who have been convicted of the animal-related offenses set forth in the Ordinance and on making that information available to animal rescue organizations or other entities that acquire animals from the County for the purpose of finding permanent homes for them; the Ordinance required the County Mayor or County Mayor's designee to provide a report to this Board regarding that directive; and

WHEREAS, to ensure that the County is not adopting animals to prohibited offenders, this Board wishes to direct the County Mayor to provide a report regarding the implementation of the Ordinance,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Mayor to provide a report regarding the implementation of Ordinance No. 18-9, including, but not necessarily limited to, the following information: (1) the methodology the Animal Services Department is using to screen for offenders; (2) whether the Department's screening has prevented offenders from adopting animals, and if so, how; and (3) the steps the Department has taken to ensure that animal rescue organizations with which the County collaborates are not adopting animals to offenders. The County Mayor shall provide the report to this Board within 60 days of the effective date of this resolution and shall place the completed report on an agenda of the Board pursuant to Ordinance No. 14-65.
