RESOLUTION CODESIGNATING, BY A THREE-FIFTHS VOTE OF BOARD MEMBERS PRESENT, THAT PORTION OF S MIAMI AVENUE FROM SE 15TH ROAD TO SE 13TH STREET/CORAL WAY AS "ALICIA CERVERA WAY"; URGING THE CITY OF MIAMI TO JOIN IN THIS CODESIGNATION

**WHEREAS**, Alicia Cervera Sr., often called the "Queen of Brickell," has participated in every Miami real estate cycle since her career here began in the 1960s; and

**WHEREAS**, she played a pivotal role in opening Miami's door to the global brokerage community and also helped revitalize neighborhoods across the region, including Brickell, Miami Beach's South of Fifth, Coconut Grove, and Edgewater; and

WHEREAS, a native of Peru, Cervera fled Cuba in 1961 with her Cuban husband Javier and arrived in Miami penniless for the first time in her life, but with hard work and determination she was able to overcome adversity and make her inspired vision for Miami real estate a reality; and

**WHEREAS**, Cervera has exclusively represented and sold more than 115 new construction condominiums in South Florida for 85 developers and sold more than 65,000 condominium units totaling more than \$16,000,000,000.00; and

**WHEREAS**, for the last 40 years, Cervera has served as president of Clinica San Juan de Dios Miami Foundation, a hospital for disabled children in her native Peru; and

**WHEREAS**, she is also an avid supporter of the American Red Cross and the Adrienne Arsht Center for the Performing Arts; and

**WHEREAS**, in recent years, Cervera has been a vocal advocate for the need to build affordable housing and believes it is one of the biggest challenges facing our community; and

WHEREAS, together with her daughters and partners, Veronica and Alicia, they continue to operate Cervera Real Estate as a family-owned business, with the main office located at 1450 S Miami Avenue; and

WHEREAS, Cervera's incredible success over so many years, particularly within the more male-dominated real estate industry, cements her as a strong role model for current and future generations of women in real estate; and

**WHEREAS**, in 2016, former Miami Mayor Tomás Regalado honored Cervera by proclaiming October 18th "Alicia Cervera Day" in the City of Miami; and

**WHEREAS**, within the proclamation he stated, "since Alicia founded the firm in 1969, no other woman has had a larger impact on the development of Miami since Julia Tuttle founded the city in 1895"; and

**WHEREAS**, March 2022 will mark Cervera's 92nd birthday and her company's 52nd year of operations; and

**WHEREAS**, this Board would like to honor Alicia Cervera Sr. and her contributions to the community by codesignating that portion of S Miami Avenue from SE 15th Road to SE 13th Street/Coral Way as "Alicia Cervera Way"; and

**WHEREAS**, that portion of S Miami Avenue from SE 15th Road to SE 13th Street/Coral Way is a County-maintained road located in the City of Miami; and

WHEREAS, this proposed codesignation is located in County Commission District 5; and

WHEREAS, Rule 9.02(d) of the Board's Rules of Procedure provides that the Commission may by a three-fifths vote of Board members present name a County road, facility or property after a living individual who has not served as an elected official within the past five years and who "has made a direct, significant lifetime contribution to this community,"

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The foregoing recitals are hereby incorporated into this resolution and this Board finds that Alicia Cervera Sr. has made direct, significant lifetime contributions to this community pursuant to Rule 9.02(d).

Section 2. Having considered this matter at a public hearing and by a three-fifths vote of Board members present, this Board codesignates that portion of S Miami Avenue from SE 15th Road to SE 13th Street/Coral Way as "Alicia Cervera Way".

**Section 3.** This Board urges the City of Miami to join in this codesignation.

Section 4. This Board directs the Clerk of the Board to transmit a certified copy of this resolution to the Mayor and City Commission of the City of Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the City of Miami Police Department and the City of Miami Fire-Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Eileen Higgins. It was offered by Commissioner

Eileen Higgins , who moved its adoption. The motion was seconded by Commissioner
