#### RESOLUTION NO. R-234-22

RESOLUTION SUPPORTING THE FEDERAL PROGRAMS AND RESOURCES FOR VETERANS AND TRANSITIONING SERVICE MEMBERS PURSUING CAREERS IN THE TRUCKING INDUSTRY MADE AVAILABLE AS PART OF THE BIDEN ADMINISTRATION'S TRUCKING ACTION PLAN TO STRENGTHEN AMERICA'S WORKFORCE

WHEREAS, due to the coronavirus disease 2019 pandemic, outdated infrastructure, and a historic volume of goods moving through the economy, the United States has experienced and continues to experience a supply chain backlog that has stressed the transportation industry and resulted in a critical shortage of truck drivers; and

WHEREAS, to combat this shortage, the Biden Administration recently launched its Trucking Action Plan to Strengthen America's Workforce, which is aimed at building a next generation trucking workforce that has access to millions of good, stable, and safe trucking jobs for years to come; and

WHEREAS, critical to these efforts are the nation's veterans and transitioning service members, whose service and commitment to this country make them uniquely qualified to help address the challenges facing the trucking industry and build the next generation's trucking workforce; and

WHEREAS, consequently, a focal point of the Biden Administration's Trucking Action Plan to Strengthen America's Workforce is veterans-focused outreach, recruitment, and training, which will expand more seamless paths for veterans and transitioning service members to access meaningful careers in the trucking industry; and WHEREAS, this includes various federal programs and resources provided by, among other federal agencies, the Department of Labor ("DOL") and the Department of Veterans Affairs ("VA"); and

WHEREAS, for example, the DOL is expanding partnerships between its Employment Navigator and Partnership Pilot and the trucking industry in order to connect transitioning service members and their spouses with best-in-class employment partners within the industry, and is also exploring the expansion of the employment readiness curriculum under its Off-Base Transition Training Pilot Program to specifically connect veterans and their spouses to a career path in trucking; and

WHEREAS, similarly, the VA is expanding its Veteran Readiness and Employment Program and Veteran Rapid Retraining Assistance Program, which assist veterans and service members with service-related disabilities and veterans who are unemployed due to the coronavirus disease 2019 pandemic, respectively, to include vocational education and training related to truck driving; and

WHEREAS, this Board wishes to express its support of these efforts taken by the federal government in providing numerous federal programs and resources to assist veterans and transitioning service members pursuing careers in the trucking industry,

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Supports the federal programs and resources for veterans and transitioning service members pursuing careers in the trucking industry made available as part of the Biden Administration's Trucking Action Plan to Strengthen America's Workforce.
