Latin Missions Ministries, Inc. (Community Youth Music Program)	\$ 10,000.00,

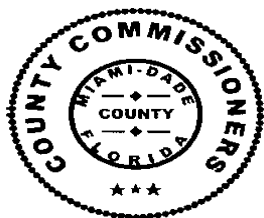
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
