RESOLUTION NO. _____ R-552-22

RESOLUTION DIRECTING THE COUNTY MAYOR OR
COUNTY MAYOR'S DESIGNEE TO IDENTIFY SUITABLE
COUNTY-OWNED PROPERTIES FOR THE TEMPORARY USE
OF RECREATIONAL VEHICLES; EXAMINE THE
FEASIBILITY OF SUCH A PROGRAM; AND REQUIRING A
REPORT

WHEREAS, a recreational vehicle ("RVs") is a motor vehicle or trailer which includes living quarters designed for accommodation. Types of RVs include motorhomes, campervans, coaches, caravans, fifth-wheel trailers, popup campers, and truck campers; and

WHEREAS, RVs have become increasingly popular and over 11 percent of Americans own an RV, with seasonal demand continuing to grow for reasons related to the pandemic, such as households wanting to spend more time outside, to take advantage of teleworking policies, and to travel more safely; and

WHEREAS, RVs are popular with seasonal visitors throughout South Florida, including Miami-Dade County; and

WHEREAS, locations for individuals to park RVs in Florida are sometimes difficult to secure; and

WHEREAS, there may be available County-owned vacant properties that are currently underutilized and would be suitable for temporary usage for RVs; and

WHEREAS, the use of RVs on County-owned property may require zone changes, permitting, electrical hookups and sewage facilities; and

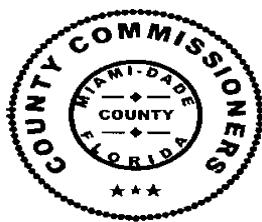
WHEREAS, this Board desires to increase the available locations for visitors and locals to utilize their RVs on a temporary basis,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby directs the County Mayor or County Mayor’s designee to, within 60 days of the effective date of this resolution, prepare a written report after assessing local need for this type of facility, and identifying suitable County-owned properties, including County parks, for temporary use by recreational vehicles. The report shall also include information related to the feasibility of such a program including possible zoning requirements, permitting issues, operational costs and other considerations, requirements of services such as electrical and sewage facilities as well as any other requirements or regulations related to the establishment of suitable RV facilities. The completed report shall be placed directly on an agenda of the full Board without committee review in accordance with Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Commissioner Jean Monestime. It was offered by Commissioner **Rebeca Sosa** , who moved its adoption. The motion was seconded by Commissioner **Raquel A. Regalado** and upon being put to a vote, the vote was as follows:
