**Subject:** Transfer of Certificate of Public Convenience and Necessity No. M-16 from Falck Southeast II, Corp. d/b/a American Ambulance Service to United Medical Transportation LLC

## **Executive Summary**

The purpose of this item is for the Board of County Commissioners (Board) to approve the transfer of Certificate of Public Convenience and Necessity (COPCN) No. M-16 currently held by Falck Southeast II, Corp. d/b/a American Ambulance Service to United Medical Transportation. The company is currently authorized to operate 43 active units and nine spare units. In August 2020, the company informed the County that it had entered into an asset acquisition agreement with United Medical Transportation, LCC, which included COPCN No. M-16.

## **Recommendation**

It is recommended that the Board approve the transfer of COPCN No. M-16 from Falck Southeast II, Corp. d/b/a American Ambulance Service to United Medical Transportation.

## **Scope**

The COPCN applies countywide, allowing the certificate holder to operate in unincorporated and incorporated areas of Miami-Dade County.

## **Delegation of Authority**

There is no delegation of authority under this item.

## **Fiscal Impact/Funding Source**

Licensing, operating, permit, and inspection fees are collected by the Miami-Dade County Department of Transportation and Public Works (DTPW) to support regulatory activities. There is minimal impact to the County since the application involves the transfer of an existing certificate. The transfer application fee collected, as established by Implementing Order No. 4-136, was \$1,500.

## **Track Record/Monitor**

This applicant will be a new certificate holder and complies with all requirements of the Code of Miami-Dade County. The principals of the corporation, Mr. Raymond Gonzalez and Mr. Rene Gonzalez, are also the principals of MCT Express, Inc. d/b/a Miami-Dade Ambulance, the holder of COPCN No. M-14, providing ground ambulance service. DTPW will be responsible for monitoring this company.

## **Background**

Chapter 4, Article I of the Miami-Dade County Code (Code), which governs ambulances and medical transportation vehicles, requires Certificates of Public Convenience and Necessity to be approved by the Board. Section 4-4(g) provides that any change in the ownership structure of a Certificate Holder that

results in a change or the possibility of change in control must also be approved by the Board. The transfer of a certificate requires that a public hearing be held. In reaching its determination, the Board shall consider the application, the County Mayor’s report and recommendation, all matters presented at the public hearing and the following criteria:

- The financial ability of the applicant to provide the proposed services;
- The adequacy of the management plan;
- Any recommendations from municipalities;
- The benefits that will accrue to the public interest; and
- The community’s need for the proposed service.

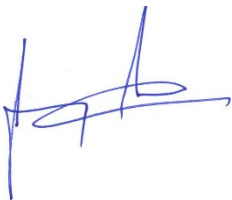
Falck Southeast II, Corp. has been providing ambulance service in Miami-Dade County since 2012. The company is currently authorized to operate 43 active units and nine spare units. In August 2020, the company informed the County that it had entered into an asset acquisition agreement with United Medical Transportation, LLC, which included COPCN No. M-16.

United Medical Transportation, LLC, located at 2766 NW 62 Street, Miami, Florida 33147, is a new certificate holder. The principals of the corporation, Mr. Raymond Gonzalez and Mr. Rene Gonzalez, currently hold COPCN No. M-14, providing ground ambulance service. The company has the necessary financial strength to sustain its operations. In accordance with the Code, staff will monitor quarterly and annual fiscal and other statistical data on an ongoing basis.

The management plan submitted by the applicant details the business functions that will be conducted and managed, including employee/crew training, a mechanism to handle complaints, accidents, maintenance, communications and dispatch, maintenance of business records and a quality assurance program. The proposed service standards meet all requirements of the Code and adequately meet transportation and comfort needs.

The benchmark response times provided by the applicant are within the parameters of being reasonably responsive to the expectations of customers and are in line with the other providers’ self-imposed schedule of benchmark response times.

A notice of the application filing was transmitted to all County municipalities and certificate holders as required. No objections were received. The public will benefit from the continued availability of a highly specialized, equipped and staffed ambulance service operating in compliance with federal, state and County regulations.

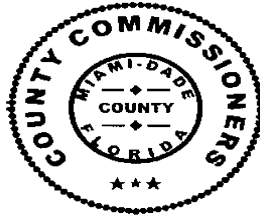
**WHEREAS**, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,
