RESOLUTION NAMING THE NEW PUBLIC HEALTH TRUST
DESIGNATED FACILITY TO BE LOCATED AT 3737 SW 8TH
STREET IN THE CITY OF CORAL GABLES THE
“JACKSON MEDICAL PAVILION”

WHEREAS, the Public Health Trust of Miami-Dade County, Florida (the “Public Health Trust”) is an agency and instrumentality of Miami-Dade County, Florida, responsible for the operation, maintenance and governance of the Jackson Health System, including, but not limited to, Jackson Memorial Hospital, Jackson South Medical Center, Jackson North Medical Center, Jackson West Medical Center, urgent care centers and outpatient facilities, and other designated facilities in accordance with Chapter 25A of the Code of Miami-Dade County; and

WHEREAS, the Public Health Trust is constructing a facility to be used as a freestanding emergency department and medical offices located on Folio Nos. 03-4105-050-2700 and 03-4105-050-2850 in the City of Coral Gables, and expected to be assigned the street address of 3737 Southwest 8th Street, which, pursuant to Resolution No. R-554-18, is a designated facility of the Public Health Trust; and

WHEREAS, the new facility under construction by the Public Health Trust will further Jackson Health System’s strategic plan to expand its ambulatory care network throughout Miami-Dade County and advance its commitment to expand health care service offerings throughout the community; and

WHEREAS, on March 30, 2022, the Board of Trustees of the Public Health Trust adopted Resolution No. PHT 03/2022-015, a copy of which is attached to this resolution, urging this Board to name the facility the “Jackson Medical Pavilion,” which name would encompass the breadth of services to be provided at the location in a way that is both clear and sufficiently flexible to absorb potential future evolution of the site; and

WHEREAS, this Board wishes to name the facility the “Jackson Medical Pavilion”; and

WHEREAS, Rule 9.02 of the Board’s Rules of Procedure provides that resolutions regarding proposed naming, renaming or codesignation of Miami-Dade County facilities or property shall be sponsored by the district commissioner where the facility or property is located; and

WHEREAS, the facility to be named is located in County Commission District 6,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

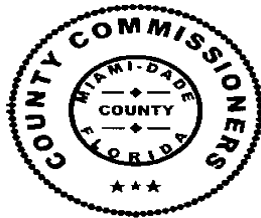
Section 1. Having considered this matter at a public hearing, names the new Public Health Trust designated facility to be located at 3737 SW 8th Street in the City of Coral Gables the “Jackson Medical Pavilion.”

Section 2. Directs the Public Health Trust to revise any references to the new Public Health Trust designated facility to the “Jackson Medical Pavilion.”

**RESOLUTION URGING THE BOARD OF COUNTY COMMISSIONERS TO
NAME THE NEW DESIGNATED FACILITY UNDER CONSTRUCTION AT
3737 SOUTHWEST 8TH STREET, CORAL GABLES, FLORIDA, AS THE
“JACKSON MEDICAL PAVILION”**

WHEREAS, under Rule 9.02 of the Board of County Commissioner’s Rules of Procedure, the Board of County Commissioners retains the authority to name non-interior portions of designated facilities of the Public Health Trust (“PHT”); and

WHEREAS, the new designated facility under construction located in the City of Coral Gables is expected to be assigned the street address of 3737 Southwest 8th Street; and

WHEREAS, the Board of Trustees of the PHT wishes to accomplish the purposes set forth in the attached memorandum from the Chief Executive Officer to the Board of Trustees, which is attached hereto and is hereby incorporated herein

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE PUBLIC HEALTH TRUST OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Recommendation

Staff recommends that the Public Health Trust Board of Trustees recommend the Miami-Dade Board of County Commissioners name the new Trust-designated facility under construction at 3737 SW 8th Street, Coral Gables, FL as "Jackson Medical Pavilion."

Scope

The proposed name would apply to the entire Trust designated facility at 3737 SW 8th Street, Coral Gables, FL which is currently programmed to include a freestanding emergency department and a suite of physician offices.

Fiscal Impact

There is no new fiscal impact to this item. Costs associated with signage are incorporated in the project budget.

Track Record & Monitor

Naming and branding for Jackson Health System facilities is overseen by Matthew I. Pinzur, Senior Vice President and Chief Marketing Officer.

Background

Jackson Health System in the process of building its first freestanding emergency department and medical office pavilion, which is under construction at 3737 SW 8th Street, Coral Gables, FL.

Staff conducted local and national market reviews to determine naming opportunities that would encompass the breadth of services provided at this location in a way that is both clear to the community and sufficiently flexible to absorb potential future evolution of the site.

Staff therefore recommends the name "Jackson Medical Pavilion."

Under Section 2-1, Rule 9.02 of the Code of Miami-Dade County, the Board of County Commissioners possesses authority to name County buildings, including Trust-designated buildings.
