The Anvil Community Development Corporation	\$ 1,170.00,

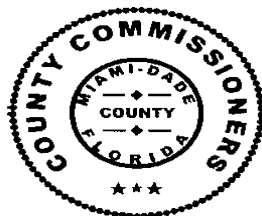
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
