RESOLUTION NO. R-660-22

RESOLUTION CALLING A COUNTYWIDE SPECIAL ELECTION IN MIAMI-DADE COUNTY, FLORIDA, TO BE HELD IN CONJUNCTION WITH A GENERAL ELECTION ON TUESDAY, NOVEMBER 8, 2022, FOR THE PURPOSE OF SUBMITTING TO THE ELECTORS OF MIAMI-DADE COUNTY THE QUESTION OF WHETHER TO AMEND THE HOME RULE CHARTER TO REQUIRE THAT COUNTY COMMISSIONERS AND THE COUNTY MAYOR, UPON TAKING THEIR OFFICE, SWEAR OR AFFIRM THAT THEY WILL SUPPORT, PROTECT AND DEFEND THE MIAMI-DADE COUNTY HOME RULE CHARTER AND THE GOVERNMENT OF MIAMI-DADE COUNTY

WHEREAS, on November 6, 1956, the people of Florida amended the Florida Constitution by adopting Article VIII, Section 11 of the Florida Constitution of 1885, preserved in Article VIII, Section 6 of the Florida Constitution of 1968 (“Home Rule Amendment”), which authorized the people of Miami-Dade County to adopt a home rule charter; and

WHEREAS, the Home Rule Amendment granted the electors of Miami-Dade County the power, within certain areas, to adopt their own rules for the government of Miami-Dade County, with the Board of County Commissioners acting as our governing body; and

WHEREAS, on May 21, 1957 the electors of Miami-Dade County adopted the Miami-Dade County Home Rule Charter (“Home Rule Charter”) which acts as the "constitution" for Miami-Dade County government; and

WHEREAS, the Home Rule Charter has protected the right of self-government in Miami-Dade County for over 65 years and has enabled the Board of County Commissioners to provide for needed services and economic opportunities for the people of Miami-Dade County; and

WHEREAS, the Home Rule Amendment properly places the ultimate political power of Miami-Dade County in its electors who alone possess the authority to amend the Home Rule Charter; and

WHEREAS, Article II, Section 5(b) of the Florida Constitution provides that state and county officers, before entering upon the duties of the office, shall give an oath by swearing and affirming that they “will support, protect, and defend the Constitution and Government of the United States and of the State of Florida” and that they “will well and faithfully perform the duties of” the office upon which they are about to enter; and

WHEREAS, the creation of a similar oath of office for elected County Commissioners and the County Mayor and thereby requiring such officers to swear and affirm that they will support, protect, and defend the Miami-Dade County Home Rule Charter and the Government of Miami-Dade County will ensure that the officials elected to represent the people of Miami-Dade County in their local government act consistent with the principles of local home rule as established by Miami-Dade County electors; and

WHEREAS, this Board desires to place a proposal to amend the Home Rule Charter on the November 8, 2022 General Election ballot to ask the electors of Miami-Dade County whether the County Commissioners and the County Mayor shall take an oath of office swearing and affirming to support, protect and defend the Miami-Dade County Home Rule Charter and Government of Miami-Dade County,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. A countywide special election is hereby called and shall be held in Miami-Dade County, Florida in conjunction with the General Election on Tuesday, November 8, 2022, for the purpose of submitting to the qualified electors of Miami-Dade County the proposal for amendment to the Home Rule Charter in the form attached hereto and made a part hereof.

Section 2. Notice of such election shall be published in accordance with section 100.342, Florida Statutes.

Section 3. The result of such election shall be determined by a majority of the qualified electors of Miami-Dade County voting upon the proposal. The polls at such election shall be open from 7:00 a.m. until 7:00 p.m. on the day of such election. All qualified electors of Miami-Dade County, Florida shall be entitled to vote at said election. The County registration books shall remain open at the Office of the Miami-Dade County Supervisor of Elections until 29 days prior to the date of such election, at which time the registration books will close in accordance with the provisions of general election laws. The question shall appear on the ballot in substantially the following form:

**CHARTER AMENDMENT CREATING LOCAL OATH OF OFFICE

SHALL THE COUNTY CHARTER BE AMENDED TO

Section 4. The form of the ballot shall be in accordance with the requirements of general election laws.

Section 5. Early voting shall be conducted in accordance with the requirements of general election laws.

Section 6. Vote-by-mail paper ballots may be used by qualified electors of Miami-Dade County for voting on this question. The form of such vote-by-mail ballot shall be in accordance with the requirements prescribed by general election laws.

Section 7. A sample ballot showing the manner in which the question or proposal aforesaid will appear at this election shall be published and provided in accordance with the applicable provisions of general election laws.

Section 8. This special election on the proposal aforesaid shall be held and conducted in accordance with applicable provisions of the general laws relating to elections and the provisions of the Home Rule Charter. The County Mayor or his or her designee, the Finance Director, and the Clerk of the County Commission are hereby authorized and directed to take all appropriate actions necessary to carry into effect and accomplish the provisions of this resolution. Election officials in connection with this election shall be appointed in accordance with the provisions of general election laws.

Section 9. This election shall be canvassed by the County Canvassing Board, in accordance with the provisions of section 3.07 of the Home Rule Charter.

The Prime Sponsor of the foregoing resolution is Chairman Jose “Pepe” Diaz. It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The motion was seconded by Commissioner **Danielle Cohen Higgins** and upon being put to a vote, the vote was as follows:

MIAMI-DADE COUNTY HOME RULE CHARTER

ARTICLE-3¹

ELECTIONS

* * *

SECTION 3.02 ~~[[RESERVED.]]~~ >>OATH OF OFFICE

In addition to the oath of office set forth in the Florida Constitution for state and county officers, each County Commissioner and the County Mayor shall, upon entering the duties of such offices, swear or affirm:

“I do solemnly swear (or affirm) that I will support, protect, and defend the Miami-Dade County Home Rule Charter and Government of Miami-Dade County and that I will well and faithfully perform the duties of (title of office) on which I am now about to enter. So help me God.”<<
