Subject: Request for Approval to Substitute Llorente & Heckler, P.A. with Marcelo Llorente,
P.A. as Associate Counsel in Pool No. RFQ-00527, Authority Bond Counsel

Summary

This item is requesting the substitution of an associate counsel for *Pool No. RFQ-00527, Authority Bond Counsel*. The pool consists of three authority counsel law firms (senior counsel) with their associated law firms (associate counsel). Senior counsel Bryant Miller Olive P.A. (BMO) has requested the substitution of Llorente & Heckler, P.A. (Llorente Heckler) as associate counsel due to termination of the joint venture agreement between the firms.

The Finance Department has determined that the substitute counsel, Marcelo Llorente, P.A. (Marcelo Llorente), has the necessary qualifications and relevant experience to serve as an associate counsel to BMO for the County's bond counsel services. The Department uses this pool to acquire bond counsel services, on an as-needed basis, for the issuance of municipal bonds through the County's peripheral authorities, including, but not limited to, the Housing Finance, Industrial Development, Educational Facilities, and the Health Facilities Authorities.

Recommendation

It is recommended that the Board of County Commissioners approve replacing Llorente & Heckler with Marcelo Llorente as associate counsel in *Pool No. RFQ-00527, Authority Bond Counsel Pool*, for the Finance Department. The Department is not requesting additional expenditure authority or additional time for the existing pool.

The County established this competitively solicited pool on November 7, 2017 for a seven-year term under Resolution No. R-993-17. The pool consists of three authority bond counsel law firms (senior counsel) with their associated law firms (associate counsel). The pool is currently in the fifth year of the contract term. Each senior counsel is required to contractually engage with an associate counsel located in Miami-Dade County to expand the availability of small and local law firms with experience in public finance.

Background

Pursuant to the solicitation, if a senior or associate counsel terminates their contractual engagement, the County may, at its sole discretion and upon approval of the Board, permit the surviving counsel to make a substitution, provided that the replacement firm meets the applicable requirements set forth in the solicitation. BMO, the senior counsel, had a joint venture agreement with Llorente & Heckler, associate counsel. Due to Llorente & Heckler winding down their law firm, BMO terminated their joint venture agreement. Based on the process defined by the solicitation, BMO, the surviving counsel, requested an associate counsel substitution to replace Llorente & Heckler with Marcelo Llorente. The Department reviewed the substitution documents submitted in accordance with the criteria outlined in the solicitation and determined that Marcelo Llorente has the necessary qualifications and relevant experience to serve as an associate counsel to BMO for the County's bond counsel services, on an as-needed basis.

Scope

The impact of this item is countywide in nature.

Delegated Authority

There is no additional delegation of authority sought in this item as the authority to exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38, subject to ratification by the Board on a bi-annual basis, was granted when the pool was established under Resolution No. R-993-17.

Fiscal Impact/Funding Source

The pool expires on February 28, 2025. The pool has a current cumulative allocation of \$4,200,000. There is no fiscal impact as this modification is not requesting additional expenditure authority. The funding source is Bond Proceeds.

Track Record/Monitor

Pearl Bethel of the Internal Services Department is the Procurement Contracting Manager.

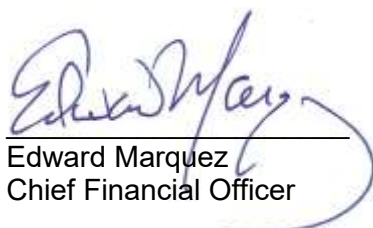

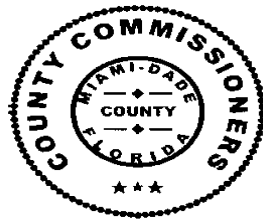
WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,
