RESOLUTION NO. _____ R-843-22

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO MONITOR PILOT PROGRAMS IN NEW YORK CITY AND SAN FRANCISCO INVOLVING A COLLABORATION BETWEEN RIDE SHARING COMPANIES AND TAXICAB OPERATORS, AND WHICH GENERALLY ALLOW TAXICAB PASSENGERS TO CALL TAXIS THROUGH A PARTICIPATING RIDE SHARING COMPANY'S PLATFORM; DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO RECOMMEND STEPS NECESSARY TO FACILITATE A SIMILAR JOINT VENTURE OR OTHER COLLABORATIVE EFFORT IN MIAMI-DADE COUNTY; AND REQUIRING A REPORT

WHEREAS, the taxicab industry provides an important service to the County's residents and visitors; and

WHEREAS, with the emergence of ride-sharing services offered by Transportation Network Companies (TNCs), more recently followed by the effects of the coronavirus disease 2019 pandemic, the local taxicab industry has suffered a steep decline in ridership and is in need of innovative solutions to ensure its continued viability; and

WHEREAS, one such potential innovation, which according to news reports, will soon be piloted in major U.S. cities, including New York City and San Francisco, takes the form of a collaborative effort between TNCs and taxicab service providers, and allows taxicab passengers to hail taxicabs through a participating TNC's platform (the "pilot programs"); and

WHEREAS, such a collaborative effort has the potential to benefit all parties involved, as for instance, (1) taxicab passengers could benefit from getting a set fare in advance of a trip based on an estimated meter rate; (2) taxicab operators could gain access to a larger pool of potential riders; and (3) TNCs could gain access to a larger supply of vehicles; and

WHEREAS, in an effort to enhance the taxicab industry's ability to remain competitive, on April 5, 2022, the Board adopted Resolution No. R-341-22, which among other things, directed the County Mayor or County Mayor's designee to work with the taxicab industry and the provider(s) of any E-Request application that has been approved by the County pursuant section 31-85(h) of the Code to develop a plan to improve the functionality of and user experience associated with the said application; and

WHEREAS, as a continuation of such efforts, the Board believes the facilitation of a joint venture or other collaborative effort involving the taxicab industry, TNCs operating in the County, and any E-Request application provider approved by the County could benefit the riding public; and

WHEREAS, the Board wishes to direct the County Mayor or County Mayor's designee to monitor the results of the pilot programs and provide a report to this Board, including any recommended steps to facilitate such a joint venture or collaborative effort in Miami-Dade County,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Directs the County Mayor or County Mayor's designee to monitor the results of pilot programs in New York City and San Francisco involving a collaboration between ride sharing companies and taxicab operators, and which generally allow taxicab passengers to call taxis through a participating ride sharing company's platform. The Board further directs the County Mayor and County Mayor's designee to recommend steps necessary to facilitate a similar joint venture or other collaborative effort in Miami-Dade County, involving (1) transportation

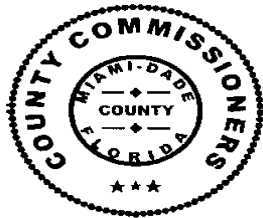
network companies (TNCs) operating in Miami-Dade County, including but not necessarily limited to Uber Technologies and Lyft, (2) the taxicab industry, and (3) any provider of an E-Request software program or application approved by the County pursuant to section 31-85(h) of the Code.

Section 2. Directs the County Mayor or County Mayor’s designee to prepare a written report regarding the directives set forth in section 1 of this resolution. The County Mayor or County Mayor’s designee shall provide the report to this Board within 60 days of the effective date of this resolution and place the completed report on an agenda of the full Board without committee review pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Commissioner Jean Monestime. It was offered by Commissioner **Sally A. Heyman** , who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
