RESOLUTION NAMING THE FUTURE NEIGHBORHOOD
PARK LOCATED AT 12821 SW 232ND STREET “JOE AND
COLLEEN GRIFFIN PARK”

WHEREAS, the property located at 12821 SW 232nd Street is owned by Miami-Dade County and is the future site of a neighborhood park to be managed by the Parks, Recreation and Open Spaces Department (“PROS”); and

WHEREAS, Joseph and Colleen Griffin were long beloved residents of the Redland area of south Miami-Dade County; and

WHEREAS, Joseph Griffin was born in Homestead on December 1, 1927; and

WHEREAS, Joseph Griffin served in the Marine Corps during World War II and following his return worked at the McArthur Dairy, Southern Bell, and as a pioneer farmer of the Redlands growing avocados and mangos; and

WHEREAS, Joseph Griffin was active in the Boy Scouts and was an Assistant Scout Master for Boy Scout Troop 69; and

WHEREAS, Joseph Griffin passed away on February 14, 2011; and

WHEREAS, Colleen Griffin was born in Abilene, Texas on July 13, 1933; and

WHEREAS, Colleen Griffin was active in the tropical fruit industry and community, and worked to help to keep Florida tropical fruits viable; and

WHEREAS, Colleen Griffin was an active member of the Mango Forum and was on the Tropical Fruit Growers of South Florida’s Board of Directors for many years; and

WHEREAS, Colleen Griffin was also a board member and president of the Redland Citizens Association, and a member of the Tropical Fruit & Vegetable Society; and

WHEREAS, Colleen Griffin was respected and admired for her work chairing the Zoning Appeals Board, never allowing her reputation to be tarnished when serving the community; and

WHEREAS, Colleen Griffin passed away on August 28, 2010; and

WHEREAS, Rule 9.02 of the Board's Rules of Procedure provides that resolutions regarding a proposed naming, renaming, or codesignation of Miami-Dade County facilities or property shall be sponsored by the district commissioner where the facility or property is located; and

WHEREAS, 12821 SW 232nd Street is located in County Commission District 8; and

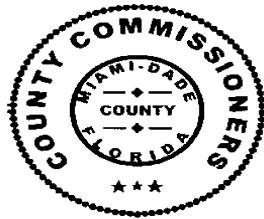
WHEREAS, this Board desires to honor Joseph and Colleen Griffin's lifetime commitment to the community,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board having considered this matter at a public hearing, names the future neighborhood park located at 12821 SW 232nd Street "Joe and Colleen Griffin Park."
