Subject: Resolution Approving the Waiver of Plat of Adrian Builders at Sunset Paradise, LLLP filed by Adrian Builders at Sunset Paradise LLLP

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for Adrian Builders at Sunset Paradise, LLLP is bounded on the north approximately 1,040 feet south of SW 68 Street, on the east approximately 300 feet west of SW 82 Avenue, on the south by SW 72 Street, and on the west by SW 82 Court.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board’s meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Legal description of the boundaries of the land are on file with the Department of Regulatory and Economic Resources.

Scope

This waiver of plat is located in Commission District 6, which is represented by Commissioner Rebeca Sosa.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

If this waiver of plat is approved, the fiscal impact to the County would be approximately \$50.00 annually for new drainage and paving construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works’ annual General Fund allocation.

Track Record/Monitor

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

Adrian Builders at Sunset Paradise, LLLP (D-24748)

- Located in Section 27, Township 54 South, Range 40 East.
- Zoning: EU-M.
- Proposed usage: One single family residence.
- Number of parcels: One.
- This waiver of plat meets concurrency.
- Available public water and sewer lines abut the proposed subdivision. The parcel is required to connect to public water and public sanitary sewers.

Developer’s Obligation

Paving, drainage, maintenance of traffic clearing, mobilization, and monumentation which are bonded under bond number 8296 in the amount of \$16,302.00.

RESOLUTION APPROVING THE WAIVER OF PLAT OF ADRIAN BUILDERS AT SUNSET PARADISE, LLLP, D-24748, FILED BY ADRIAN BUILDERS AT SUNSET PARADISE, LLLP, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 27, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH APPROXIMATELY 1,040 FEET SOUTH OF SW 68 STREET, ON THE EAST APPROXIMATELY 300 FEET WEST OF SW 82 AVENUE, ON THE SOUTH BY SW 72 STREET, AND ON THE WEST BY SW 82 COURT)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

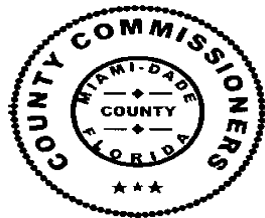
WHEREAS, Adrian Builders at Sunset Paradise, LLLP, a Florida limited liability limited partnership, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the Southwest 1/4 of Section 27, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said waiver of plat is hereby approved; that the property has been found to be in compliance with Chapter 28, Subdivisions, of the Miami-Dade County Code; that approval of this waiver of plat is not a waiver of any zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this waiver of plat conforms to those requirements.
