JEFFERSON STREET AS “CHERYL E. JOHNSON WAY”**

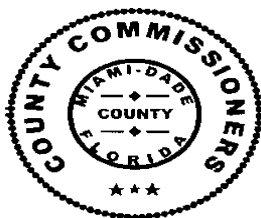
