Subject: Recommendation for Approval to Establish a Prequalification Pool for Construction Equipment Rental

Summary

This item is for the establishment of a prequalification pool which will be used for rental of construction equipment and equipment operator services for multiple County departments. Rental of construction equipment includes, but is not limited to, air compressors, aerial lift platforms, backhoes, bucket trucks, drills, light towers, mobile cranes, forklifts, tractors, and generators. The equipment operator services include the purchase of operators for powered industrial trucks such as low lift and high lift trucks, rough terrain forklift trucks, industrial crane trucks, and operator controlled industrial tow tractors. County departments rely on this equipment in their daily operations for the maintenance and repair of infrastructure.

The pool will be used by multiple County departments, including the Department of Transportation of Transportation and Public Works (DTPW) and Water and Sewer Department (WASD), to meet their operational needs and to facilitate the repair and maintenance of equipment and facilities. WASD has the highest requested allocation and will use the pool in anticipation of needed maintenance projects and/or pump station power outages and other infrastructure unforeseen emergencies or community events. DTPW has the second-highest requested allocation and will use the pool for rail fastener replacement, cover board replacement and other rehabilitation and operation projects due to aging. Utilizing the pool facilitates the maintenance and repair of infrastructure and allows these and other departments to respond to unforeseen emergencies in a timely manner.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the establishment of a prequalification pool, *RTQ-02115, Construction Equipment Rental* for multiple County departments with an allocation of \$32,154,000 for a five-year term. This pool will replace *Prequalification Pool No. 8446-5/17-1, Construction Equipment Rental*, which was established by the Board through Resolution No. R- 228-08 for a five-year term, with one five-year option to renew term; and was subsequently extended for an additional five years through Resolution No. R-206-18. The original pool was established with 11 vendors, of which nine were local, including one certified Small Business Enterprise (SBE) firm. The pool currently has 27 vendors, of which 16 are local, including two certified SBE firms.

The SBE measures and Local Preference will be applied at the time of spot market competition, where permitted by funding source. Each spot market quote issued under this solicitation must be submitted to the Small Business Development (SBD) Division for review. To track pool expenditures by vendor, bidding under this and other prequalification pools will gradually be conducted and monitored in a single platform, INFORMS, which will allow staff to provide data reports to the Board, as requested.

This item is placed for Board review pursuant to Miami-Dade County Code Section 29-124(f)(ii). Since this is a transit-related procurement, with a value of more than \$1 million, even though no Charter County Transportation Surtax Funds will be used to pay the costs, the Board may only consider this item if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the Board. If the CITT has not forwarded a recommendation and 45 days have not elapsed since the issuance of this recommendation, a withdrawal of this item will be requested. It should be noted that of the \$32,154,000 being requested, only \$6,383,000 is for DTPW.

Background

The pool will consist of two groups: Group A will be for the rental of construction equipment and Group B will be for the rental of equipment operator services. The pool will allow County departments to source items for each project to meet operational needs while enhancing competition. Vendors in the pool will be invited to participate in future spot market competition, as needed.

To ensure maximum opportunity for local and small businesses to participate in this solicitation, prior to advertisement, the scope of services was posted to the County's future solicitations website for two weeks. The solicitation was advertised on BidSync with 2,115 notifications sent out, from which 43 suppliers viewed the notification and six responded. This prequalification will remain advertised on the County's website to encourage additional participation.

Scope

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The fiscal impact for the five-year term is \$32,154,000. The current pool, 8446-5/17-1, has a cumulative allocation of \$73,504,000 for a fifteen-year and three month term, which expires on June 30, 2023. The allocation being requested under the replacement pool is higher than the allocation under the current pool on an annualized basis due to increases in some departments anticipated operational needs.

*It should be noted that contracts contain termination for convenience provisions, which can be exercised if the commodities and services in this item are affected by the establishment of the constitutional offices.

Track Record/Monitor

Manuel Jimenez of the Strategic Procurement Department is the Procurement Contracting Manager.

Delegated Authority

Upon approval of this item, a pool of prequalified vendors will be established to participate in spot market competitions. The County Mayor or the County Mayor's designee will have the authority to solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board. The County Mayor or the County Mayor's designee will also have the authority to (a) exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38 and (b) add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis.

Vendors Prequalified for Pool

A Request to Qualify was issued and, as of the submittal deadline, six vendors responded to the solicitation for Group A only. However, after the solicitation closed, two submittals were received from local firms for Groups A and B, of which one is a certified SBE firm. The submittals were evaluated and the vendors will be added to the pool after it is established. There are six vendors being recommended for inclusion in the pool under Group A, as set forth in the table below, all of which have local addresses, and none are certified SBE firms.

In addition, a third local and incumbent vendor, which is also a certified SBE firm, has submitted documents for inclusion in both groups, but their submittal is incomplete. Staff will continue to follow up with this vendor, and the vendor will be added once prequalification requirements are met. Outreach to firms will continue to encourage additional participation by local qualified vendors.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with the Internal Services Department's Procurement Guidelines to determine vendor responsibility, including verifying corporate status and that there are no performance and compliance issues. The lists that were referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. The review revealed that two vendors - Sunbelt Rentals, Inc. and Herc Rentals, Inc. - had histories of Occupational Safety and Health Administration (OSHA) complaints; however, the vendors are working with OSHA to resolve all complaints. None of the aforementioned complaints for the two vendors adversely impact the County's pool and there were no other findings relating to vendor responsibility.

Pursuant to Resolution No. R-140-15, prior to re-procurement, a full review of the scope of services was conducted to ensure the replacement pool reflects the County's current needs. The review included conducting market research, posting a draft solicitation for industry comment, and holding meetings and drafting sessions with the user departments. The scope of services was updated to include additional construction equipment manufacturers for Groups A and B.

Applicable Ordinances and Contract Measures

- The two percent User Access Program provision applies where permitted by the funding source.
- Each spot market quote issued under this solicitation must be submitted to SBD for review.
- Local Preference will be applied at the time of spot market competition, where permitted by the funding source.
- The Living Wage and Responsible Wages do not apply as the services are not covered under the Ordinances.

RESOLUTION AUTHORIZING ESTABLISHMENT OF PREQUALIFICATION POOL NO. RTQ-02115 FOR MULTIPLE COUNTY DEPARTMENTS FOR A FIVE-YEAR TERM IN A TOTAL AMOUNT UP TO \$32,154,000.00 FOR THE PURCHASE OF CONSTRUCTION EQUIPMENT; AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO SOLICIT PRICING, AWARD CONTRACTS, EXERCISE ALL PROVISIONS OF THE SOLICITATION DOCUMENTS AND ANY RESULTING CONTRACTS PURSUANT TO SECTION 2-8.1 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA AND IMPLEMENTING ORDER 3-38, AND ADD VENDORS TO THE POOL AT ANY TIME, SUBJECT TO RATIFICATION BY THE BOARD ON A BI-ANNUAL BASIS

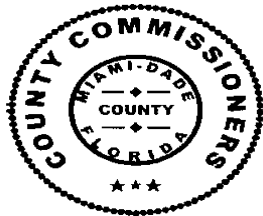
WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes the establishment of Prequalification Pool No. RTQ-02115 for multiple County departments for a five-year term in a total amount up to \$32,154,000.00 for the purchase of construction equipment rental; and authorizes the County Mayor or County Mayor's designee to (a) solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board, (b) exercise all provisions of the solicitation documents and any resulting contracts pursuant to section 2-8.1 of the Code of Miami-Dade County, Florida and Implementing Order 3-38, and (c) add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis.
