Subject: Recommendation for Approval to Establish a Prequalification Pool for Janitorial Supplies and Related Items

Summary

This item is for the establishment of a prequalification pool for the purchase of janitorial supplies and related items for multiple County Departments. The pool provides for the purchase of janitorial supplies, including cleaners, disinfectants, hand sanitizers, dispensers, brooms, brushes, mops, sponges, buckets, waste receptacles, and waste can liners. Janitorial supplies are critical for the maintenance of County facilities to ensure the safety and well-being of staff and patrons. Departments will use this pool to maintain the hygienic conditions of County buildings and facilities, including garages, libraries, park sites and correctional facilities maintained by the Department of Corrections and Rehabilitation, the largest user of the pool.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the establishment of *Prequalification Pool No. EVN0000040, Janitorial Supplies and Related Items* for multiple County departments with an allocation of \$19,348,000 for a five-year term. The Small Business Enterprise (SBE) measures will be determined prior to advertising each spot market competition. To track pool expenditures by vendor, bidding under this and other prequalification pools will gradually be conducted and monitored in a single platform, INFORMS, which will allow staff to provide data reports to the Board, as requested. Fifteen of the recommended vendors have a local address, of which eleven are certified SBE firms. The pool will remain open to allow additional vendors that meet the prequalification criteria to be added throughout the pool's duration.

Background

This pool will replace the existing contract, *FB-00634, Janitorial Supplies and Related Items*, which was approved by the Board through Resolution No. R-887-18 for a five-year term. The contract was subsequently modified under delegated authority and by the Board via Resolution No. R-949-20 due to the increased usage of janitorial supplies during the COVID-19 pandemic.

Scope

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The fiscal impact for the five-year term is \$19,348,000. The current contract, *FB-00634*, is valued at \$14,448,000 for a five-year term. The allocation under the pool is higher than the previous pool due to the market's uncertainty and increase in supply cost.

*It should be noted that contracts contain termination for convenience provisions, which can be exercised if the commodities and services in this item are affected by the establishment of the constitutional offices.

This item is placed for Board review pursuant to Miami-Dade County Code Section 29-124(f)(ii). Since this is a transit-related procurement, with a value of more than \$1 million, even though no Charter County Transportation Surtax Funds will be used to pay the costs, the Board may only consider this item if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the Board. If CITT has not forwarded a recommendation and 45 days have not elapsed since the issuance of this recommendation, a withdrawal of this item will be requested. Further, it should be noted that of the \$19,348,000 being requested, \$1,400,000 is for the Department of Transportation and Public Works.

Track Record/Monitor

Alonzo Joseph of the Strategic Procurement Department is the Procurement Contracting Manager.

Delegated Authority

Upon approval of this item, a pool of prequalified vendors will be established to participate in spot market competitions. The County Mayor or the County Mayor's designee will have the authority to solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board. The County Mayor or the County Mayor's designee will also have the authority to (a) exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38 and (b) add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis.

Vendors Prequalified for Pool

Twenty-five vendors responded to the solicitation, and 19 are being recommended for inclusion in the pool as set forth in the table below. Fifteen of the recommended vendors have a local address, of which eleven are certified SBE firms.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with the Strategic Procurement Department's Procurement Guidelines to determine vendor responsibility, including verifying corporate status and that there are no performance and compliance issues through various vendor responsibility lists and a keyword internet search. The lists that were referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to vendor responsibility.

Pursuant to Resolution No. R-140-15, prior to re-procurement, a full review of the scope of services was conducted to ensure the replacement pool reflects the County's current needs. The review included conducting market research, posting a draft solicitation for industry comment, and holding meetings and drafting sessions with the user departments. The scope of services includes updates to all specifications under the current contract, FB-00634.

Applicable Ordinances and Contract Measures

- The two percent User Access Program provision applies where permitted by the funding source.
- The Small Business Enterprise (SBE) set-aside applies for spot market competition up to \$250,000 of at least two available SBE certified firms or over \$250,000 of at least three available SBE certified firms, where permitted by the funding source. Bid preference will apply when there are less than three certified SBE firms capable of providing the requested goods. Each spot market quote under this pool must be submitted to the Small Business Division of the Internal Services Department for review.
- The Local Preference will be applied where permitted by the funding source.
- The Living Wage Ordinance does not apply as this is for the purchase of goods.
- The Responsible Wages and Benefits Ordinance does not apply as this is for the purchase of goods.

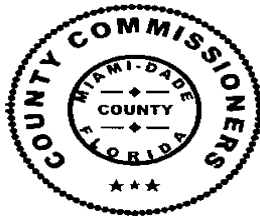
WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes the establishment of Prequalification Pool EVN0000040 for multiple County departments for a five-year term in a total amount up to \$19,348,000.00 for the purchase of janitorial supplies and related items; and authorizes the County Mayor or County Mayor's designee to (a) solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board, (b) exercise all provisions of the solicitation documents and any resulting contracts pursuant to section 2-8.1 of the Code of Miami-Dade County, Florida and Implementing Order 3-38, and (c) add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis.
