Parks Foundation of Miami-Dade, Inc.	\$7,500.00,

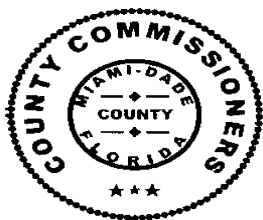
