Zoo Miami Foundation, Inc.	\$5,000.00,

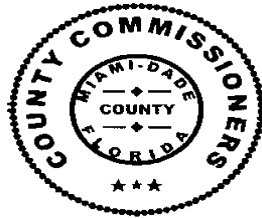
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
