Midwest District Mounted Patrol Unit \$50,000.00.

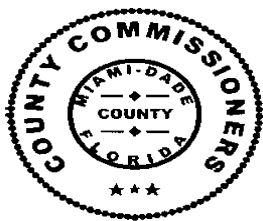
Section 2. Approves the following allocation from FY 2021-22 District 6 CBO
