Subject: Contract Award Recommendation in the Amount of \$14,835,037.25 to General Asphalt Co. LLC for Roadway Improvements to NE 151 Street from East of Railroad Tracks to Bay Vista Boulevard

Executive Summary

The purpose of this item is to gain approval of the Board of County Commissioners (Board) to execute a contract award for the project titled "Roadway Improvements to NE 151 Street from East of Railroad Tracks to Bay Vista Boulevard" in the amount of \$14,835,037.25 to General Asphalt Co. LLC. NE 151st Street from Biscayne Boulevard to Bay Vista Boulevard serves as the main entrance to educational institutions such as Florida International University Biscayne Bay Campus, the David Lawrence Jr. K-8 School, and the Alonzo & Tracy Mourning Senior High School.

This corridor expansion would relieve the current traffic congestion and provide improved mobility for the planned enhancements to Florida International University by reconstructing the existing NE 151 Street four-lane road to a six-lane road, from Biscayne Boulevard to Bay Vista Boulevard. These improvements include, but are not limited to: raising medians; adding widened sidewalks and dedicated bicycle lanes; improvements to the stormwater drainage system, as well as curbs and gutters; new pavement marking and signage; and roadway lighting and environmental mitigation. The project addresses capacity for the anticipated growth of the other educational institutions along the route and other planned growth in the area. The project will also enhance safety for pedestrians, cyclists and other users, aligning with the goals of the County's Vision Zero initiative, enhancing the pedestrian experience as part of a Complete Streets design. Last, the project ensures ADA compliance, providing facilities for multiple modes of transportation. The project is being funded by Road Impact Fees (RIF), as it is taking place to alleviate congestion that has resulted from increased development in the area.

Recommendation

This contract award recommendation for the project titled "Roadway Improvements to NE 151 Street from East of Railroad Tracks to Bay Vista Boulevard," Project No. 20210092, in the amount of \$14,835,037.25 to General Asphalt Co. LLC was prepared by the Department of Transportation and Public Works (DTPW) and is recommended for approval by the Board.

Delegation of Authority

The authority of the County Mayor or County Mayor's designee to execute and implement this contract and to exercise the termination and other provisions therein is consistent with those authorities granted under the Code of Miami-Dade County. No additional authority is being requested within the body of this contract.

Track Record / Monitor

EXPLANATION:

This project was advertised on August 25, 2022. On October 5, 2022, six engineering contractor firms proffered bids. Of the six, there were three responsive and responsible bids. The lowest bidder, General Asphalt Co. LLC, proffered a base bid of \$13,328,754.32, which was 24.32 percent above the County's cost estimate. The second lowest bidder, JVA Engineering Contractor Inc., proffered a base bid of \$13,653,025.69, which was 27.34 percent above the County's cost estimate. Lastly, the third lowest bidder, Magnum Construction Management, proffered a base bid of \$13,968,000.00, which was 30.28 percent above the County's cost estimate. Price fluctuation in the context of today's volatile COVID-19 supply-chain environment accounts for the difference between preliminary cost estimates and bids proffered.

This project was bid on a unit price basis. A copy of all bids, and the bid tabulation for this project, is available by contacting the Chief of Capital Improvements, DTPW.

DTPW has reviewed the Capital Improvements Information System (CIIS) database and found a total of 25 awarded construction contracts for General Asphalt Co. LLC. In addition, a total of 46 evaluations were found in CIIS with an average rating of 3.6 out of a possible total of 4.0 points. As such, DTPW recommends that General Asphalt Co. LLC, the lowest responsive, responsible bidder, be awarded this contract for the sum of \$14,835,037.25.

Following DTPW's standard operating procedures, after award of this contract, a pre-construction meeting will be scheduled. After completion of the award process, the project will be assigned to Leo Salgueiro, Project Manager, DTPW for contract monitoring and compliance.

Pursuant to Board policy, a safety records check for the recommended awardee was conducted. Based on OSHA records from the last five years, DTPW did not find any significant issues. A copy of the OSHA reports is available upon request.

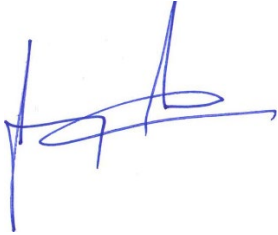

BACKGROUND: NE 151st Street from Biscayne Boulevard to Bay Vista Boulevard serves as the main entrance to educational institutions such as Florida International University Biscayne Bay Campus, the David Lawrence Jr. K-8 School and the Alonzo & Tracy Mourning Senior High School. A feasibility study prepared in 2015 by R.J. Behar & Company, Inc. for DTPW recommended to widen the segment from four to six lanes. The study took into consideration a Planning Study prepared by Kimley-Horn and Associates, Inc. for the Miami-Dade County MPO in 2011 whose purpose was to evaluate the feasibility of adding another entrance to FIU's Biscayne Bay Campus,

concluding that the only feasible access improvement was to expand NE 151st Street from a four- to a six-lane roadway from Biscayne Boulevard to Bay Vista Boulevard. This corridor expansion will relieve the current traffic congestion and provide improved mobility for the planned enhancements to Florida International University, anticipated growth of the other educational institutions along the route, and the planned development of the Biscayne Landing Community.

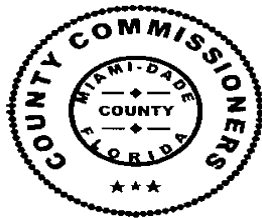
WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

It is further mutually agreed that if at any time after the execution of this Contract and the Performance Bond and Payment Bond, the County shall find the surety upon such bonds to be unsatisfactory, or if for any reason such bond shall become inadequate to cover the performance of the work, the Contractor shall at his own expense, within five (5) days after the receipt of notice from the County to do so, furnish an additional bond or bonds in such form and amount and with such surety or sureties as shall be satisfactory to the County. In such event, no further payment to the Contractor shall be deemed to be due under this Contract until such new or additional surety shall have been furnished in a manner and form satisfactory to the County.
